Dear Mr. Milgrub:

Mr. Robinson presented himself to me for the purpose of evaluating his capacity to own and use firearms safely and responsibly. We met on 6/21/05 for interview and selective projective testing designed to understand his motives and capability for these purposes. He cooperatively met all requirements of the evaluation, permitting a reliable sample of his adjustment.


Historically, Mr. Robinson lived in a single parent home and his mother had difficulty in managing him. He developed Oppositional Defiant Disorder behavior of significant proportion to require placement out of the home by the time he was fourteen years of age when he attempted to run from home. He was in a shelter for a month, 6 months in the Nittany Home for Boys and from there he was sent to the Meadows Psychiatric Hospital where the diagnosis was made. After completing high school, he lived with his father in Philadelphia where he painted houses for three years before returning to western Pennsylvania. For the past 10 years he has worked as a welder for the Marathon Equipment Co. His six year marriage ended with his wife's infidelity—they had no children. He is currently planning to be married in September, 2005.

During his earlier years, he did abuse alcohol and other controlled substances. He has not used the controlled substances for some time and he states that his alcohol intake is two six packs of beer per week. He denies current drinking to intoxication.

Projective test findings depict him as being of average intellect and capable of demonstrating appropriate contact with reality. He is capable of perceiving a satisfactory number of popular a measure of his ability to relate with his environment successfully. He tends to be a bit cautious in engaging his environment more readily. Thus, he tends to be a quiet person who moves a bit cautiously in life. He is a rather private person, most likely dealing with others on a personal level after they have initiated the relationship style. This restriction would be an outcome of his early life disappointments. He recognizes emotional stimulation on all levels and manages to deal with it adequately. When strong emotional stimulation was presented, he delayed his initial response, and then he permitted himself to be more responsive. There was no indication of loss of control over his behavior. He demonstrates adequate value structure and values.

The general test/evaluation picture reflects adequate values and priorities in life as well as normal emotional control. There is no indication that he would present any threat in managing firearms.
