COMPLAINT

1. Plaintiff is a corporation having offices in Glen Burnie, Maryland.
2. Defendant, TQA Fabrications, Inc., is a corporation having its offices and place business at 164 Industrial Road, Clearfield, Clearfield County Pennsylvania 16830.
3. To induce the extension of credit, Defendant executed and delivered to Plaintiff an Application for Credit, a true and correct copy of which is attached hereto, marked Exhibit "1", and made a part hereof.
4. At the special instance and request of Defendant, Plaintiff sold and delivered to Defendant certain goods, wares and merchandise, as is more specifically shown by Plaintiff's invoices, copies of which are attached hereto, marked Exhibit "2" collectively, and made a part hereof.
5. Defendant received and accepted the aforementioned goods, wares and merchandise.
6. The prices charged by Plaintiff were the fair, reasonable, and market prices that prevailed at the times of the transactions.
7. The prices charged by Plaintiff were the prices that Defendant agreed to pay.
8. Plaintiff avers that the balance due amounts to \$10,216.17, as is more specifically shown by Plaintiff's Statement, a true and correct copy of which is attached hereto, marked Exhibit "3", and made a part hereof.
9. Plaintiff avers that the agreement between the parties provides for service charges at the rate of 1.5% per month.
10. Plaintiff avers that service charges amount to \$957.77 to May 9, 2005.
11. Plaintiff avers that the agreement between the parties provides that Defendant will pay Plaintiff's collection costs (including reasonable attorneys' fees) in the amount of 25% of the balance due.

12. Plaintiff avers that such reasonable collection costs (including reasonable attorneys' fees) will amount to \$2,793.49.

13. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and refused to pay the aforesaid balance, service charges, attorneys' fees, or any part thereof to Plaintiff.

WHEREFORE, Plaintiff demands Judgment against Defendant in the amount of \$13,967.43, with continuing service charges thereon at the rate of 1.5% per month and costs.

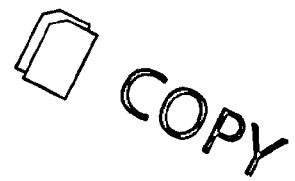

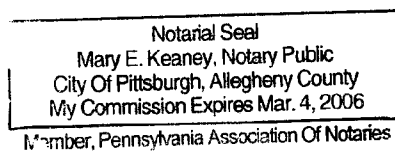

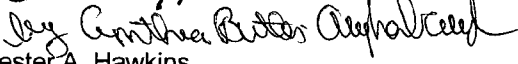
