



9. A True and correct copy of Krunal R. Patel's Birth Certificate is attached hereto and incorporated herein by reference as Exhibit A.


10. Your Petitioner files this Petition to correct public records so that they reflect the proper and pronunciation of his first name.



6. This search of the official records at each courthouse shows no judgments, orders, decrees or other matter pending against the subject of this Petition Krunal R. Patel.




