**WAIVER OF RIGHT TO FILE LIEN**

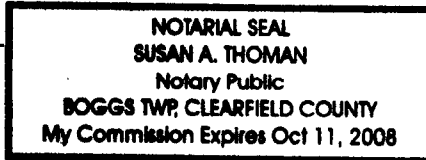

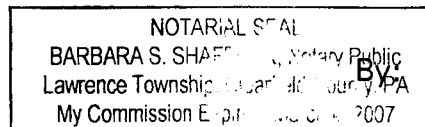
