

AND NOW comes your Petitioner, Pamela L. Gaines, a/k/a Pamela Disshon, on behalf of her minor child, Jacob James Scribe, by and through her counsel, John A. Sobel, IV, Esquire, who avers as follows:

1. That your Petitioner is Pamela L. Gaines, a/k/a Pamela Disshon, of 803 Morrison Road, Clearfield, Pennsylvania, 16830.
2. That your Petitioner is the natural mother of the minor child, Jacob James Scribe, who was born on July 20, 2002, as so evidenced by a copy of his birth certificate, which will be presented to the Court at hearing.
3. That the natural father of the child is Joseph J. Scribe, who is currently incarcerated at SCI Camp Hill, Box 8837, Camp Hill, PA, 17001-8837.
4. That the natural father does not pay support for the care of the child through the Domestic Relations Office of Clearfield County.
5. That your Petitioner has referred to the minor child as Jacob Disshon as often as she has referred to the child as Jacob Scribe.
6. That the child has always understood that his last name is Disshon and is not familiar with the name Jacob James Scribe.

7. That the child is getting older and will soon be of age to attend pre-school as well as kindergarten and elementary school.

8. That it is the desire of your Petitioner that the child's name be changed from Jacob James Scribe to Jacob James Disshon in order that the child not be confused or suffer any undue stress stemming from his last name being different from his natural mother's.


9. That the natural father will be given notice of this hearing.
