

**COMPLAINT**

NOW COMES Plaintiff Evansville Veneer, a division of Kimball Inc., by its attorneys, Lee, Green & Reiter, Inc., and respectfully represents:

1. Plaintiff is Evansville Veneer, a division of Kimball Inc, a Delaware corporation with a place of business located at 7988 Gardner Road, Chandler, Indiana 47610.
2. Defendant is Shelly Reed, an adult individual residing at 189 Sawmill Road, Wallaceton, Pennsylvania 16876, who at all times relevant to this civil action, did business as Wallaceton Hardwoods with a place of business located at 171 Reed Street, Wallaceton, Pennsylvania 16876.
3. At all times relevant to this civil action, Plaintiff was engaged in the retail and wholesale sale of lumber and other wood products.
4. On or prior to August 5, 2003, Defendant requested that she be permitted to purchase lumber and other wood products from Plaintiff on credit.
5. Plaintiff approved said request, established an account for Defendant and permitted her to purchase lumber and other wood products from it on credit.
6. Between August 5, 2003 and December 31, 2003, Defendant purchased lumber and other wood products from Plaintiff of the description, at the prices and on the terms set forth in


the invoices, true and correct copies of which are attached hereto, incorporated herein and collectively marked as Exhibit "A."

6. Defendant received and accepted the lumber and other wood products above described.
7. The prices charged for the lumber and other wood products were fair and reasonable and the prices Defendant agreed to pay.
8. At the present time, the principal sum of \$15,551.74 is due and owing to Plaintiff from Defendant for the purchases above described.
9. Pursuant to the terms of the purchases above described, payment was due within thirty (30) days of shipment.
10. Plaintiff has complied with all conditions precedent to payment of the amount presently due and owing from Defendant.
11. Despite a demand therefore, Defendant has failed and refused to pay Plaintiff the principal amount plus interest presently due and owing.

WHEREFORE, Plaintiff demands judgment in its favor and against Defendant in the principal amount of \$15,551.74, plus interest at the rate of 6% in the amount of \$1,693.86 and costs.






