
### COMPLAINT

1. Plaintiff is a corporation with offices in 370 17<sup>th</sup> Street, Suite 5000, Denver, CO 80202.
2. Defendant is an adult individual residing at 75 Freedom Road, Dubois, PA 15801.
3. Defendant applied for and received a credit card issued by Plaintiff's assignor bearing the account number 5408010008148146.
4. Defendant made use of said credit card and has currently a balance due and owing to Plaintiff, as of July 13, 2005, in the amount of \$2,853.98.
5. Defendant is in default of the terms of the cardholder Agreement having not made monthly payments to Plaintiff thereby rendering the entire balance immediately due and payable.

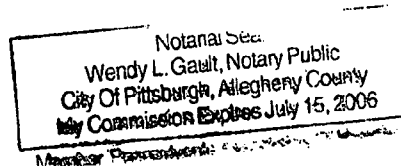
