C O M P L A I N T

AND NOW, comes the Plaintiffs, GEORGE E. TAYLOR and DONNA M. TAYLOR, by and through their attorneys, GLEASON, CHERRY AND CHERRY, L.L.P., and bring this Complaint against Defendant, ROBERT C. BURNS, individually and t/d/b/a BURNS CONTRACTING, on a cause of action whereof the following is a statement:

1. Plaintiffs, GEORGE E. TAYLOR and DONNA M. TAYLOR, are adult individuals, husband and wife, whose residence address is 1451 Treasure Lake, DuBois, Pennsylvania 15801.
2. Defendant, ROBERT C. BURNS, is an adult individual, trading and doing business as BURNS CONTRACTING, with a business address at 1356 Treasure Lake, DuBois, Pennsylvania 15801.
3. On June 29, 2001, Defendant prepared and submitted to Plaintiffs a certain written proposal for the construction of a home for Plaintiffs being 1,148 square feet with a 400 square foot finished basement and a 564 square foot garage for a total price of \$92,600.00. A true and

correct copy of the proposal made by Defendant and accepted by Plaintiffs is attached hereto and made a part hereof as Exhibit "A".

4. The Plaintiffs have fulfilled all the provisions of the proposal on their part to be performed.

5. The Defendant has not fulfilled the provisions of the agreement on his part to be performed.

6. That Defendant commenced construction of the premises situate on Lot 159, Section 15 on Caribbean Road in the Treasure Lake Subdivision of Sandy Township on September 11, 2001.

7. That at all times during the construction of the premises, Plaintiffs relied upon the expertise of the Defendant who held himself out as a professional contractor with experience in the field of construction.

8. That Defendant was aware of the contour of the site prior to his commencement of construction of the premises and despite having promised Plaintiffs a finished basement, Defendant wholly failed to take those steps required to assure that the basement would be waterproof and performed other work in a poor, improper and unworkmanlike manner causing water to enter the basement of Plaintiffs' home.

9. That during construction, Plaintiffs noticed that ground water had leaked through the basement walls onto the first floor and notified Defendant of this problem but Defendant assured them that this situation would be alleviated after the house was finished.

10. That after Plaintiffs moved into the home in the Spring of 2002, Plaintiffs began to notice stains on the drywall in the basement and that water was creeping onto the floor because the carpeting was wet.

11. That thereafter, Plaintiffs began to notice that mold was accumulating on the walls of the basement and on the cabinetry installed in the basement.

12. That Plaintiffs repeatedly contacted Defendant with their complaints and repeatedly requested that he return to the premises but Defendant failed and wholly refused to cure the aforesaid breaches, despite Plaintiffs' repeated demands.

13. Defendant has wholly neglected to do and perform certain things which were expressly or by necessary implication required to be done and performed by the agreement he made to provide Plaintiffs with a finished basement, as follows:

- (a) installing a rubber membrane to the exterior walls of the home structure;
- (b) installing trench drains around the structure to receive and carry storm water away from the basement area of the house;
- (c) contouring the front yard away from the house to keep storm water from being transported to the finished basement.

14. Defendant has performed in a poor, improper and unworkmanlike manner certain other things which were expressly or by necessary implication required by the agreement reached by the parties to be done and performed in a proper and workmanlike manner, as follows:

(a) He discharged the roof drain leaders into the same corner of the dwelling before routing them to day light in the back yard, causing water to collect at the basement corner and seep through the exterior walls of the basement into the interior of Plaintiffs' home.

(b) Applying cementious parging and tar sealer to the basement walls when he knew or should have known that such a procedure would be insufficient to insure a water-free basement.

15. That because Defendant wholly refused to remedy the situation or to provide Plaintiffs with any instruction as to what they could do to remedy the situation, Plaintiffs were forced to hire an engineer to provide them with instruction as to how they could correct the situation brought about by Defendant after the house was constructed at a cost to them of \$650.00.

16. That in order to remedy the aforesaid breaches of the Defendant, Plaintiffs were required to install additional french drains and to re-plant and re-mulch the area surrounding their house where the landscaping had to be dug up for the installation of these french drains at a cost of \$2,295.00. A true and correct copy of the invoice paid by Plaintiffs for this work is attached hereto and made a part hereof as Exhibit "B".

17. That because Defendant had not properly waterproofed the basement, Plaintiffs were required to install a sump pump system at a cost of \$4,800.00. A true and correct copy of that bill is attached hereto and made a part hereof as Exhibit "C".


18. Finally, because of the aforesaid breaches by Defendant, Plaintiffs had to repair water damage to their drywall, cabinets, shower and had to install another shower door at a

total cost for labor and materials of \$550.00. A true and correct copy of that bill is attached hereto and made a part hereof as Exhibit "D".

WHEREFORE, Plaintiffs demand judgment against Defendant in the amount of \$8,295.00, together with interest thereon from December 26, 2003, to the present and costs of suit.
