ALL that certain piece or parcel of land situate in Boggs Township, Clearfield County, Pennsylvania, being bounded and described as follows:

BEGINNING at a stake, which is the corner of lands now or formerly of H. J. Goss land and lands now or formerly of James Lumadue; thence South 254 feet along the line of lands now or formerly of H.
