COMPLAINT IN ASSUMPSIT

The plaintiff brings this action in assumpsit upon a cause hereinafter set forth.

1. 2. The defendant, Williams & Green Company, Inc., is a corporation, and has its main offices at 1310 South Second Street, in the City of Clearfield, Clearfield County, Pennsylvania.

3. The plaintiff is in the business of supplying industrial steel and pipe in the Borough of St. Marys.

4. On or about the 1st day of January, 1960, and at various dates thereafter, the plaintiff, at the request of the defendant, sold and delivered to the defendant goods, wares and merchandise at the times, in the amounts, of the kinds, and for the prices set forth in a true and correct copy of account taken from the plaintiff's books of original entry hereto attached and marked Exhibit "A".


5. The prices charged for said goods, wares and merchandise are just and reasonable and are the prices which the defendant promised to pay the plaintiff for the same.
