***WAIVER OF MECHANIC'S LIEN***

THIS AGREEMENT, waiving the right to file Mechanic's Lien, is made this 13th day of October, 2005, between BARRY L. STEINKAMP a/k/a BARRY L. STEINKEMP and MARY JO STEINKAMP a/k/a MARY JO STEINKEMP, with mailing address of 222 Center Street, Wallaceton, Pennsylvania, 16876, hereinafter called "OWNERS", and FAMILY MOBILE HOMES, INC. with place of business at 3170 Clearfield-Woodland Highway, Woodland, Pennsylvania 16881, hereinafter referred to as "CONTRACTOR".

WHEREAS, CONTRACTOR has agreed to furnish certain materials and labor for the construction of a mobile home on all that certain piece or parcel of land situate in the Borough of Wallaceton, Clearfield County, to which OWNERS took title by deed in Clearfield County Record Volume 1784, Page 418, and is more particularly described as follows:

**ALL that piece or parcel of land situate in the Borough of Wallaceton, County of Clearfield, and State of Pennsylvania, bounded and described as follows, to wit:**

**BEGINNING at a point on an alley and ninety (90') feet distant from Graham Street in said Borough and thence in an Easterly direction along other land of the former Grantor a distance of one hundred (100') feet to line of post of the land now or formerly of Frank Goss; thence in a Southerly direction along line now or formerly of Frank Goss, ninety (90') feet to an alley; thence in a Westerly direction along said alley a distance of one hundred (100') feet**

to a point on another alley; thence along said other alley in a Northerly direction ninety (90') feet to point and place of beginning.

NOW, THEREFORE, it is hereby stipulated by and between the said parties as part of the said Contract and for the consideration set forth, that before any of the above construction is commenced, neither the undersigned CONTRACTOR, any sub-contractor or Materialman, nor any other person furnishing labor or materials to the said CONTRACTOR under the contract above referred to, shall file a lien commonly known as a Mechanic's Lien, for work done or materials furnished to the said building or any part thereof.

This stipulation is made and intended to be filed with the Clearfield County Prothonotary in accordance with the requirements of the Act of Assembly of Pennsylvania in such cases made and provided.

CONTRACTOR acknowledges that he, it or they have inspected the land in question and that no part of it has been disturbed by the CONTRACTOR or any one claiming by or through him prior to the execution of this Agreement.




