**PETITION FOR NAME CHANGE**


NOW COMES the Petitioner, Harlan Eugene Boaz, and by his Attorneys, Belin & Kubista, petitions the Honorable Court for the change of his name, and avers as follows:

1. That Petitioner is Harlan Eugene Boaz, an adult individual residing at 623 First Street, Grampian, Clearfield County, Pennsylvania, 16838.
2. That Harlan Eugene Boaz is thirty-five (35) years of age (d.o.b. 1/1/70) and was born out of wedlock to Emmerson Eugene Boaz and Patricia Marlene McCarchey in Bloomington, Illinois.
3. That for all of his life, Petitioner believed that his true name was Harlan Eugene Sylvester. Recently, Petitioner obtained a copy of his birth certificate and learned that his name as set forth thereon was Harlan Eugene Boaz.
4. That for all of his life, Petitioner has used the name of Harlan Eugene Sylvester and the Petitioner desires to legally change his name to Harlan Eugene Sylvester.
5. That during the last eleven (11) years, Petitioner has resided at the address set forth at Paragraph 1 herein above.
6. Other than the aforementioned birth certificate, all other significant documents including his social security card, driver's license, and bank accounts have been held by Petitioner in the name of Harlan Eugene Sylvester.

7. There are no judgments or decrees of record or any other matter of like character against Harlan Eugene Boaz.

WHEREFORE, Petitioner respectfully requests that the Honorable Court, pursuant to the Act of December 16, 1982, P.L. 1309, No. 295, Section 2, 54 Pa.C.S.A. § 701, to set a hearing on this Petition for purposes of considering a decree to change the name of Harlan Eugene Boaz to Harlan Eugene Sylvester.
