
PETITION TO DISAPPROVE SALE


WHEREFORE, your Petitioner respectfully requests that the bid received by the Tax Claim Bureau for the interest of Patricia K. Soult be disapproved.





ANSWER OF CLEARFIELD COUNTY TAX
CLAIM BUREAU TO PETITION TO DISAPPROVE
PRIVATE SALE

TO: The Honorable Fredric J. Ammerman, President Judge

AND NOW COMES, Clearfield County Tax Claim Bureau ("Bureau") by Kim C. Kesner, Esquire, Clearfield County Solicitor and files this Answer to the Petition to Disapprove Sale as directed by this Court's Order of November 14, 2005 as to why the Petition should not be granted:

1. Admitted.
2. The Tax Claim Bureau is without sufficient knowledge or information to form a belief of the averments contained in Paragraph 2.
3. Admitted
4. It is admitted that the Tax Claim Bureau received an offer to purchase the subject assessment at private sale under Section 613 of the Real Estate Tax Sale Law, 72 P.S. §5861.613 on October 1, 2004. It was accepted by the Tax Claim Bureau on March 16, 2005. Notice of the proposed sale and time to file objections was published in accordance with §613 and mailed to County National Bank, Executor of the Estate of Patricia K. Soult by Certified Mail which was received on July 29, 2005. The time for filing objections to the proposed sale under §613 expired on September 28, 2005. The Petition here was filed on November 10, 2005 and therefore is untimely.
5. Admitted.

6. Petitioner's subjective belief on the sufficiency of the proposed sale price is irrelevant and immaterial. The Petition alleges no facts or circumstances which if proven support a conclusion that the offer approved by the Tax Claim Bureau is insufficient. The averments contained in Paragraph 6 of the Petition are in adequate as a matter of law to support further proceedings. By way of further answer, the subject assessment was administered by County National Bank, Executor of the Estate of Patricia K. Soul but were treated as having no value (see Schedule A Inheritance Tax Return Est. File No. 1991-0024).

WHEREFORE, the Clearfield County Tax Claim Bureau respectfully requests your Honorable Court to dismiss the Petition.






