PETITION FOR CHANGE OF NAME

AND NOW, comes the Petitioner, ASHLEY NICOLE ROMERO, by her attorneys,
Dennison, Dennison & Harper, who file the Petition For Change of Name pursuant to 54
Pa.C.S.A. §701 et seq., and in support thereof make the following averments:

1. The Petitioner, Ashley Nicole Romero, an adult individual, was born on August 24, 1987, and she is eighteen (18) years of age.
2. Jennifer J. Haggerty is the mother and natural guardian of Ashley Nicole Romero.
3. Ashley Nicole Romero was born out-of-wedlock and there is no father listed on her birth certificate.
4. At the time of the birth of the Petitioner, Jennifer J. Haggerty was unmarried and her maiden name was Jennifer J. Romero.
5. At the time of the Petitioner's birth, she was given her mother's maiden surname.
6. In December of 1993, Jennifer J. Romero and Daniel Haggerty, Jr., were lawfully married, and thereby the Petitioner's mother's lawful name was changed from Jennifer J. Romero to Jennifer J. Haggerty.
7. In and around August of 2004, Jennifer J. Haggerty and Daniel Haggerty, Jr., were lawfully divorced.

8. Despite the divorce, the Petitioner's mother, Jennifer J. Haggerty, decided to retain her married surname and intends to continue to use the name.

9. In the last three years, the Petitioner has resided at 1146 Treasure Lake, DuBois, Clearfield County, Pennsylvania, with her mother, Jennifer J. Haggerty.

10. There are no judgments or decrees of like character of record against Ashley Nicole Romero.

11. The Petitioner, Ashley Nicole Romero, requests that her name be changed from Ashley Nicole Romero to Ashley Nicole Haggerty.

12. The reason for the requested change is to conform the adult child's name with the name of her natural mother and legal guardian, with whom she presently resides and has continuously resided with since her birth.

WHEREFORE, the Petitioner, Ashley Nicole Romero, respectfully requests that Your Honorable Court enter an Order changing the adult child's name from Ashley Nicole Romero to Ashley Nicole Haggerty.
