MOTION FOR EXPEDITED CONSIDERATION OF
PLAINTIFF'S MOTION TO COMPEL AND FOR
SANCTIONS AGAINST DEFENDANTS, AND SEEKING
SUPPLEMENTARY RELIEF IN AID OF EXECUTION

AND NOW comes Plaintiff, RONALD HAMLIN, by and through his counsel, McQuaide, Blasko, Fleming & Faulkner, Inc. and files the within Motion for Expedited Consideration of Plaintiff's Motion to Compel and for Sanctions Against Defendants as follows:

1. The instant proceedings concern efforts by Plaintiff to collect a judgment entered against Defendant Shelly K. Reed and her fictitious name alter-ego, Wallaceton Hardwoods, in the amount of \$198,043.52 plus accrued costs and additional interest..
2. Based on information and belief, on or about March 22, 2007, the Sheriff of Clearfield County served on Defendants Reed and Wallaceton copies of the Writ of Execution in this matter, and Interrogatories and Requests for Production in Aid of Execution, copies of the latter of which are attached hereto as Exhibit "A."
3. The discovery requests to Defendant seek disclosure and production of evidence of Defendants' assets so as to assist Plaintiff and the Sheriff in completing the levy and collection of the judgment.

4. As of the date hereof, Defendants have not responded to the discovery requests, in violation of the applicable Rules of Civil Procedure.

5. Based on information and belief, Shelly K. Reed and Wallacetton Hardwoods have been avoiding the Sheriff's efforts to levy, including but not limited to having employees and/or agents of Wallacetton Hardwoods refuse to disclose to the Sheriff the residence and/or location of Shelly K. Reed, who has not been present at the main place of business/log yard and warehouse of Shelly K. Reed/Wallacetton Hardwoods when the Sheriff has on more than one occasion appeared to serve documents and levy.

6. In addition, Plaintiff fears that Defendants are inappropriately transferring and hiding funds and assets from its creditors, such as Plaintiff herein, in an improper attempt to avoid levy and satisfaction of Plaintiff's judgment.

7. It is further averred that Plaintiff has had the Sheriff serve numerous area banks as garnishees, but to date only limited funds have been frozen and subject to attachment and judgment.

8. In that Shelly K. Reed/Wallacetton Hardwoods operates a business in Wallacetton, Clearfield County, Pennsylvania which employs numerous persons, said business cannot conceivably operate without substantial funds on account to meet payroll, utility obligations, and transact business.

9. Shelly K. Reed's fictitious name alter-ego, Wallacetton Hardwoods, is operated on a day-to-day basis by Merwin Graham, whose name and that of his sons' (Mark Graham and Michael Graham) appear on Reed/ Wallacetton's CSB Bank account, per Exhibit "B," attached hereto. Shelly K. Reed also testified in her sworn deposition of March 1, 2004, that Merwin Graham has lived with her for twenty (20) years, and they are "really good friends," and he has

Reed's "full authority . . . to run the company while I'm not there. . . (and when Reed is present as well, though she had the final say.)."

10. Based on information and belief, the Sheriff has levied on logs stored at the premises, however, a claimant identified as Bruce Graham, who is likely the brother or close relative of Merwin Graham, has asserted all of same are his and none supposedly of Reed/Wallacetton, and are purportedly valued at \$248,000. Moreover, Bruce Graham apparently asserts that he has or purportedly will transfer such substantial funds to Reed/Wallacetton, however, the bank accounts levied upon to date have not contained such sums of money.

11. It has also come to the attention of counsel for Plaintiff that recently, additional funds were wired into Defendants' attached CSB Bank account, which Defendants have since apparently tried to rescind so as to avoid legal process and the Sheriff's levy and attachment of such funds in the possession of said garnishee bank.

12. Defendants neglect and/or refusal to respond to Plaintiff's discovery requests and actions as above noted appears to be part of Defendants' strategy and tactic to avoid and obstruct lawful process and collection of Plaintiff's judgment.

13. Pa. R.C.P. No. 3118 authorizes this Honorable Court to grant supplementary relief in aid of execution to the Plaintiff, beyond the discovery in aid of execution authorized by Rule 3117.

WHEREFORE, Plaintiff respectfully requests this Honorable Court grant Plaintiff an expedited hearing on this matter and issuance of an Order:


(a) Compelling full and complete disclosure of all assets of Defendants and responses to Plaintiff's discovery requests within ten (10) days hereof;






