PETITION FOR CHANGE OF NAME

TO THE HONORABLE, THE JUDGES OF SAID COURT:

The Petition of Wendy Peachman, mother of Lyn Ann Peachman, by her attorney Chris A. Pentz, respectfully represents:

1. The minor child was born on February 14, 1994 under the name of Lyn Ann Muir.
2. The minor child was adopted by Kenneth L. Peachman in 1996 with her name being changed to Lyn Ann Peachman.
3. Father (Kenneth L. Peachman) and Mother (Wendy Peachman) divorced in 2001.
4. Since Mother and Father separated, Father's contact with the minor child has been by personal visits on approximately two (2) occasions during the Christmas holiday of 1999 and approximately two (2) phone calls.
5. The minor child does not have any contact with her Peachman relatives.
6. The minor child has extensive contact with her relatives on her mother's side, being the Dipko relatives.
7. Mother's maiden name was Wendy Elizabeth Dipko.
8. If the Court grants this request of a name change, it is the intent of Mother to assume her maiden name.

9. Mother is not presently married and does not have any other children.

10. The minor child has resided with her mother since December of 1998 in the Houtzdale, Clearfield County, Pennsylvania area.

11. Mother believes and therefore avers that Father, Kenneth L. Peachman, who resides at 306 Fourth Street, Shenandoah, Virginia 22848, does not oppose the change of the minor child's name.

12. There are no judgments or decrees of like character of record against the minor child.

WHEREFORE, Petitioner requests the Court, pursuant to the Act of December 16, 1982, P.L. 1309, No. 295, § 2, 54 Pa. Cons. Stat. Ann. § 702, for the following:

- a. Schedule a hearing on this Petition.
- b. To direct that notice of this Petition and hearing be given to Kenneth L. Peachman; and
- c. To enter a decree changing the minor child's name from Lyn Ann Peachman to Lyn Ann Dipko.




