COMPLAINT

AND NOW, comes the Plaintiff, by and through its attorneys, and the law firm of Wolpoff & Abramson, L.L.P., and files the within Complaint and in support avers as follows:

1. Plaintiff, GREAT SENECA FINANCIAL CORP., A MARYLAND CORPORATION, ASSIGNEE OF HOUSEHOLD AUTOMOTIVE CORP, is a corporation doing business within the Commonwealth of Pennsylvania and the other states of the United States, with its principal offices located at P.O. Box 1651, Rockville, MD 20849.

2. Defendant, WILLIAM E. CLUTTER, is an adult individual with a last known address of 1157 Ansonville Road, Irvona, Clearfield County, PA 16656-9031.

3. On May 28, 1999, Plaintiff's assignor and Defendant entered into a written automobile loan agreement under which Plaintiff's assignor financed for Defendant Sixteen Thousand Seven Hundred Sixty-Four and 60/100 (\$16,764.60) Dollars. A copy of the sales contract is attached hereto as Exhibit "A."

4. By the terms of the sales contract, Defendant agreed to make total payments in the amount of Twenty-Seven Thousand Four Hundred Twenty-One and 20/100 (\$27,421.20) Dollars, which payments were due, through sixty (60) consecutive

monthly payments of Four Hundred Fifty-Seven and 02/100 (\$457.02) Dollars, the first payment being due on July 12, 1999.

5. Defendant is in default of the sales contract by his failure to make any of the agreed upon payments since August 5, 2004.

6. The automobile was rightfully repossessed and sold at auction on August 2, 2004. The net sale price was One Thousand Two Hundred Fifty-Two and 00/100 (\$1,252.00) Dollars. A copy of the auction receipt is attached hereto as Exhibit "B."

7. Defendant's account was credited for the amount received for the automobile at auction.

8. The balance due under the contract is Six Thousand Eight Hundred Twenty-Four and 44/100 (\$6,824.44) Dollars, including interest.

9. Plaintiff also claims reasonable attorney fees of One Thousand Two Hundred Twelve and 06/100 (\$1,212.06) Dollars which are payable under the terms of the contract and Pennsylvania law.

10. Any and all conditions precedent to the bringing of this action have been performed by Plaintiff.

11. The amount in controversy is within the jurisdictional amount requiring compulsory arbitration.

WHEREFORE, Plaintiff, GREAT SENECA FINANCIAL CORP., A MARYLAND CORPORATION, ASSIGNEE OF HOUSEHOLD AUTOMOTIVE Finance Corp., respectfully requests this Honorable Court enter judgment in favor of Plaintiff and against Defendant, WILLIAM E. CLUTTER, in the amount of Six Thousand Eight Hundred Twenty-Four and 44/100 (\$6,824.44) Dollars, including interest, reasonable attorney fees in the amount of One Thousand Two Hundred Twelve and 06/100 (\$1,212.06) Dollars. plus costs of this action and such other relief as the Court deems proper and just.
