TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE OF SAID COURT:

The joint Petition of Elaine Kronenwetter and Linda M. Kronenwetter, minors, by Herbert E. Kronenwetter, their father and natural guardian, and Herbert E. Kronenwetter and Lena I. Kronenwetter in propria persona, and United Services Automobile Association, insurance carrier of Rear Admiral Robert E. Cronin, by Gleason, Cherry & Cherry, their attorneys, respectfully represents:

1. Elaine Kronenwetter is a minor of the age of 15 years and resides with her father and mother, the said Herbert E. Kronenwetter and Lena I. Kronenwetter, at Weedville, Pennsylvania.

2. Linda Kronenwetter is a minor of the age of 18 years and resides with her father and mother the said Herbert E. Kronenwetter and Lena I. Kronenwetter at Weedville, Pennsylvania.

3. That Linda Kronenwetter and Elaine Kronenwetter, minors, were on August 16, 1959, passengers in a 1958 Ford owned by Joan Coradi and operated by Vincent Coradi when the said Ford was struck by a 1954 Chevrolet two-door owned by Rear Admiral Robert E. Cronin and operated by Robert E. Cronin, Jr. The accident occurred at the intersection of highway routes 255 and 153 in the Village of

Penfield, Clearfield County, Pennsylvania when the said Robert E. Cronin, Jr. failed to bring his vehicle to a stop at a stop sign on said route 153 and struck the vehicle in which the minor plaintiffs were passengers.

4. That as a result of the aforesaid accident, Herbert E. Kronenwetter incurred the following expenses for medical attention for the said minors all of which were paid under a medical provision of the Insurance Company of the said Joan Coradi:

5. That Rear Admiral Robert E. Cronin, one of the defendants and owner of the aforesaid Chevrolet, is insured by United Services Automobile Association, which company has negotiated a settlement with Herbert E. Kronenwetter, father of Linda and Elaine Kronenwetter, for the injuries received by Linda and Elaine Kronenwetter. The settlement figure for Linda Kronenwetter is in the total sum of \$2250.00 and the settlement figure for Elaine Kronenwetter is in the total sum of \$550.00. Said settlement figures were agreed upon directly between a representative of the insurance company and Herbert E. Kronenwetter without the intervention of legal counsel on the part of either.

6. That your petitioner, Gleason, Cherry & Cherry, represent United Services Automobile Association for the purpose of preparing the necessary papers to present to your Honorable

Court for approval of the settlement and that said attorneys do not represent Herbert E. Kronenwetter and have performed no services for him other than preparing a praecipe directing the Prothonotary to issue a summons as above captioned, which said praecipe was signed personally by Herbert E. Kronenwetter and Lena I. Kronenwetter.

7. That your petitioners Herbert E. Kronenwetter and Lena I. Kronenwetter, feel that the settlement offered by United Services Automobile Association in the gross amounts of Two Thousand Two Hundred Fifty (\$2,250.00) Dollars in Linda Kronenwetter's case and Five Hundred Fifty (\$550.00) Dollars in Elaine Kronenwetter's case is fair and reasonable under the circumstance and request your Honorable Court to approve the same and direct distribution.

8. That Elaine Kronenwetter apparently has no permanent injury or disability attributable to the accident, as is evidenced by statement of P. J. Valigorsky, M. D. which is attached hereto and made a part hereof.

9. That Linda Kronenwetter apparently has no permanent injury or disability attributable to the accident other than a crooked nose which will require surgery to straighten out the same. N. D. Yingling, M. D. of Clearfield, Pennsylvania has informed your petitioners that it will cost approximately One Thousand (\$1,000.00) Dollars for surgery that will be necessary to correct the nose of Linda Kronenwetter. Statements of L. J. Cherry, M. D., G. S. Cherry, D. D. S. and N. D. Yingling, M. D. are attached hereto and made a part hereof. Letter of F.E. Murdock, M.D., is also attached hereto and made a part hereof.

10. Attached hereto is a letter from William L. White, M.D. who is going to operate on the nose of Linda Kronenwetter.

WHEREFORE, your petitioners jointly pray your Honorable Court to approve the settlement in the gross amount of Five Hundred Fifty (\$550.00) Dollars in the case of Elaine Kronenwetter and the gross amount of Two Thousand Two Hundred Fifty (\$2,250.00) Dollars in the case of Linda Kronenwetter, and they will ever pray.

Miss Linda Kronenwetter was involved in a motor accident on August 16, 1959.

I saw her in the emergency room of the Maple Avenue Hospital. She had a 10cm laceration of the left side of her forehead, 4cm laceration of the right side of her forehead, 2.5cm laceration of right upper eyelid, cerebral concussion and contusion of the nose. X-rays of the nose revealed no fractures or dislocations as did x-rays of the skull.


She was discharged on February 6, 1960. Residual was a scar on her forehead, otherwise she has recovered completely.



Total	\$ 550.00


