**NOTICE OF LICENSE SUSPENSION APPEAL**


AND NOW, comes the Defendant, Wayne Thomas, by and through his counsel, Frederick M. Neiswender, Esquire, and hereby presents notice to the Commonwealth of Pennsylvania Department of Transportation of his intent to appeal a license suspension and avers the following:

1. Defendant is Wayne Thomas of 4067 Chestnut Grove Highway, P.O. Box 77, Grampian, Pennsylvania 16830.
2. On December 16, 2005, Defendant pled guilty to a citation, which alleged a violation of 75 Pa.C.S.A. §1606(A) Driving a Commercial Vehicle Without a Commercial Driver's License.
3. On December 30, 2005, Defendant received notice from the Department of Transportation that as a result of his plea to the citation, his commercial operating privileges would be suspended for six (6) months as mandated by statute. *See attached Exhibit "A"*
4. Defendant was not aware that his commercial operating privileges would be suspended when he pled guilty to the citation.
5. Defendant was not driving without a commercial driver's license (CDL), but rather unbeknownst to him, his CDL had expired a few weeks earlier.
6. A six (6) month suspension to his CDL would place an undue financial hardship on the Defendant.

WHEREFORE, Defendant requests that this Court schedule Defendant for a license suspension appeal hearing and grant Defendant a supersedeas to stay his license suspension so that he may continue to drive commercial vehicles during the pendency of the appeal.
