

AND NOW, this 5th day of August, 2003, upon
consideration of plaintiffs' uncontested renewed motion for
judgment on decision (docket entry # 25), and the Court finding
that:

(a) On March 31, 2003, we granted plaintiffs'
uncontested motion for summary judgment against defendant Edward
Dworetzky for violation of Section 12 of the Securities Act of
1933, 15 U.S.C. § 77l(a)(1), and Section 502 of the Pennsylvania
Securities Act of 1972, 70 Pa. C.S. § 1-502 ("Section 502");

(b) Plaintiffs' renewed motion for judgment on
decision seeks \$288,500.00 in compensatory damages and
\$103,860.00 in interest at the statutorily mandated rate of six
percent per annum for the period between July 1997, when the last
securities transactions at issue in this case occurred, and July
2003, see 41 Pa. C.S. § 202 (providing that the "legal rate" of
interest under Pennsylvania law is six percent);
