COMPLAINT

AND NOW, comes Plaintiffs, by and through their attorneys, Hopkins Heltzel LLP, and sets forth the following two (2) count Complaint and avers as follows:

COUNT I

Easement by Prescription

1. Plaintiffs are Donald E. Swan, Barry L. Swan, Paul Muth, William James Muth, James L. Murdock and Louis Murdock, who maintain a principal business address at 506 Filbert Street, Curwensville, Pennsylvania 16833.
2. The Defendant is Brian Sekula, an adult individual, who resides at 949 Sunset Lake Road, Rockton, Pennsylvania 15856.
3. Plaintiffs are the owners of a certain tract of land situate in Bell Township, Clearfield County, conveyed to them by Donald E. Swan and Virginia Swan, Paul Muth, Louis Murdock and Margie Murdock and recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania as Instrument No. 200004518.

4. The Plaintiffs predecessors in title, some of whom include their parents, acquired title to the property by Deed dated October 30, 1953 and recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania in Deed Book Volume 433, at page 517.

5. Since acquiring the property in 1953, predecessors in title to the Plaintiffs constructed a roadway from Township Route 3009 across lands of William Haggey (now Michael Weber and John Weber) pursuant to a written Right of Way.

6. Since 1953, Plaintiffs and their predecessors in title have traveled across Haggey/Weber (now Weber property) pursuant to their right of way and have also traveled across lands of Defendant Brian Sekula to Plaintiffs' property consisting of a land locked hunting camp.

7. Attached hereto as Exhibit "A" is a tax map showing the road way utilized by Plaintiffs to access their property. Attached as Exhibit "B" are two photographs of the roadway as it crosses Defendant Sekula's property.

8. Plaintiffs' use of the right of way as been adverse, open, notorious, continuous and uninterrupted for over twenty one (21) years.

9. Plaintiffs and their predecessors in title, use of the roadway across Defendant Brian Sekula's property for a period of time in excess of twenty one (21) years entitled Plaintiffs to an easement by prescription.

10. Said roadway is fifteen (15') feet wide and hundred thirty two (132') feet long.

WHEREFORE, Plaintiffs respectfully request this Honorable Court enter an Order to be recorded in the Office of the Recorder of Deeds of Clearfield County

confirming Plaintiffs, their successors and assigns, licensees and invitees are granted access across a fifteen (15') foot by one hundred thirty two (132') foot roadway through lands of the Defendant Brian Sekula to Plaintiffs' property.

COUNT II

Easement by Adverse Possession

11. Plaintiffs incorporate the allegations set forth in Count I of their Complaint as if set forth at length herein.

12. Plaintiffs' use of Defendant's land has been actual, visible, notorious, exclusive and distinct, hostile and continuous for over twenty one (21) years.

WHEREFORE, Plaintiffs respectfully request this Honorable Court enter an Order to be recorded in the Office of the Recorder of Deeds of Clearfield County confirming Plaintiffs, their successors and assigns, licensees and invitees are granted access across a fifteen (15') foot by one hundred thirty two (132') foot roadway through lands of the Defendant Brian Sekula to Plaintiffs' property.

COUNT III

Private Road Law

13. Plaintiffs incorporate the allegations set forth in Count I and Count II of their Complaint as if set forth at length herein.

14. Plaintiffs pursuant to 36 P.S. §2731-2891 and related acts of the Commonwealth of Pennsylvania are entitled to have a private road opened across lands

of the Defendant Brian Sekula following the same courses and distances as an existing roadway currently used by Plaintiffs.

15. Plaintiffs are the owners of a certain tract of land situate in Bell Township, Clearfield County, conveyed to them by Donald E. Swan and Virginia Swan, Paul Muth, Louis Murdock and Margie Murdock and recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania as Instrument No. 200004518.

16. There is no reasonable road or access from the Plaintiffs' said described land to a public road or place of necessary public resort or to any private way leading to a public road.

17. Defendant Brian Sekula is the owner of an adjacent tract of land to that land of Plaintiffs over which a private road extending across a valid right of way to a public road is feasible.

18. Without such a road, the Plaintiffs are unable to use their property without undue burden and hardship.

19. Plaintiffs request that a private road be laid out approximately fifteen (15') wide and one hundred thirty two (132') feet long and opened in such manner as your Honorable Court may deem appropriate over the lands of Brian Sekula in accordance with the Acts of 1836, June 13, P.L. 551, Section 11; 1901, April 4, P.L. 65, No. 32, Section 1; and 1927, April 28, P.L. 485, Section 1, 36 P.S. §2731-2891.

WHEREFORE, Plaintiffs respectfully request this Honorable Court enter an Order to be recorded in the Office of the Recorder of Deeds of Clearfield County confirming Plaintiffs, their successors and assigns, licensees and invitees are granted

access over a fifteen (15') foot by one hundred thirty two (132') foot roadway across lands of the Defendant Brian Sekula to Plaintiffs' property.


