3. Defendant applied for and received a credit card bearing the account number 5291071487717140 .


4. Defendant made use of said credit card and has a current balance due of \$2215.59 , as of March 09, 2006 .



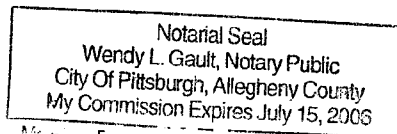


