



PETITION UNDER 21 P.S. 688 TO SATISFY MORTGAGE

Helen E. Strunk, through her Attorney, Joseph Colavecchi, Esquire files this Petition to satisfy a mortgage and respectfully avers as follows:

1. Petitioner is Helen E. Strunk, an individual residing at 100 Virginia Street, Clearfield, Pennsylvania, 16830.

2. Defendant is Budget Plan Consumer Discount Company of Clearfield, Pennsylvania, its Successors and Assigns, being a corporation authorized to do business under the laws of the Commonwealth of Pennsylvania, formerly having a place of business at 23 North Second Street, Clearfield, Pennsylvania, 16830.

3. Leslie E. Strunk, Jr., the deceased husband of Helen E. Strunk, entered into a mortgage with Budget Plan Consumer Discount Company of Clearfield, Pennsylvania dated April 14, 1981, recorded

at Clearfield County Mortgage Book 375, Page 298, said mortgage being in the amount of Seven Thousand Thirteen Dollars and Eighty-eight Cents (\$7013.88). A copy of said mortgage is attached to this Petition marked Exhibit "A".

4. The land described in said mortgage has been sold by Helen E. Strunk, the surviving widow of Leslie E. Strunk, Jr., and it is necessary that the mortgage to Budget Plan Consumer Discount Company of Clearfield, Pennsylvania be satisfied of record.

5. Budget Plan Consumer Discount Company of Clearfield, Pennsylvania no longer exists and as of the date of filing this Petition, the successor, or whoever has taken over the company or dissolved the company, has not been found.

6. The mortgage with Budget Plan Consumer Discount Company of Clearfield was to commence payments on May 20, 1981, with the last payment to be made on May 20, 1984. It has now been more than twenty-two (22) years since the last payment under this mortgage was due. There is a presumption of payment from lapse of time.

7. No telephone number in Pennsylvania can be found listing Budget Plan Consumer Discount Company. Petitioner is attaching hereto, marked Exhibit "B", a list of the various corporations that were known as Budget Plan Consumer Discount Company in Pennsylvania and it is respectfully alleged that none of them are in business to the best of Petitioner's knowledge, information and belief.

8. No demand has ever been made on Petitioner or her husband to the best of the knowledge, information and belief of Petitioner for payment of this mortgage.

9. It is respectfully averred that Petitioner, who has no debt, believes that said mortgage was paid many years ago and it was never noted on the record that the mortgage was satisfied.

WHEREFORE, Petitioner is requesting that the court issue an Order directing that public notice be advertised in the Clearfield Progress and in the Clearfield County Legal Journal once a week for four (4) weeks, successively, and that said Petition to satisfy the above mortgage be presented requiring any person or persons appearing who claim to be the holder or holders of said mortgage to show cause why said mortgage should not be satisfied. In the event that no one appears to dispute the satisfaction of said mortgage or fails to establish why said mortgage cannot be satisfied, the court would then issue an Order directing that the Budget Plan Consumer Discount Company mortgage described above be satisfied of record by the Recorder of Deeds of Clearfield County, Pennsylvania upon payment of the costs to enter said satisfaction. Further, that said satisfaction shall thereafter discharge, defeat and release this mortgage and shall likewise bar all actions brought or to be brought thereon as fully and effectually to all

KNOW ALL MEN BY THESE PRESENTS: That whereas, the undersigned borrowers named above (hereinafter called Mortgagors) have become justly indebted to the company named above (hereinafter called the Mortgagee) in the amount shown, payable as above set forth and evidenced by a promissory note of even date herewith, and whereas, said Mortgagors are desirous of securing the prompt payment of said note when the same falls due. This Mortgage and the Lien thereon shall be security for this debt and for any and all loans that may be made by MORTGAGEE to MORTGAGOR at any future time; provided, however, that at no time shall the sum of the unpaid balances of the present debt and all subsequent loans exceed the full amount of the present debt.

MORTGAGOR promises to pay the above mentioned debt as required by said note, and any future loans as required; that buildings on the premises shall be kept insured against loss by fire for benefit of MORTGAGEE, in companies and amounts satisfactory to MORTGAGEE, with a standard mortgage clause; and MORTGAGOR will pay any tax or other legal assessment imposed upon said premises. 


