**NOTICE OF LICENSE SUSPENSION APPEAL**


AND NOW, comes the Defendant, Chris A. Centra, Jr., by and through his counsel, Frederick M. Neiswender, Esquire, and hereby presents notice to the Commonwealth of Pennsylvania Department of Transportation of his intent to appeal a license suspension and avers the following:

1. Defendant is Chris A. Centra, Jr. of 485 East 10<sup>th</sup> Street, Clearfield, Pennsylvania 16830.
2. On January 10, 2006, Defendant was sentenced on a violation of 35 Pa.C.S.A. §780-113(a)(31)(i), Possession of Marijuana-Small Amount.
3. On March 16, 2006, Defendant received notice from the Department of Transportation that as a result of his plea to the above charge, his operating privileges would be suspended for six (6) months as mandated by statute. *See attached Exhibit "A"*
4. Defendant was not aware that his operating privileges would be suspended when he pled guilty to the charge.
5. At the time Defendant was sentenced, the Court did not order a license suspension, nor was the Defendant required to surrender his driver's license.
6. In reliance upon the belief that his operating privileges would not be suspended, Defendant accepted employment that requires significant travel in his personal vehicle as well as company owned vehicles.
7. A six (6) month suspension of his operating privileges will result in the Defendant losing his employment and would place an undue financial hardship on the Defendant.

WHEREFORE, Defendant requests that this Court schedule Defendant for a license suspension appeal hearing and grant Defendant a supersedeas to stay his license suspension so that he may continue to drive motor vehicles during the pendency of the appeal.
