At a previous date the price was known to be \$.26 per square foot. I installed 5,280 square feet of drywall, 110 sheets 4x12, which equals \$1,372.80.

On or about October 3, 2005 Bryan Componation informed me that I was no longer needed, that someone else was hired to finish the drywall.

On October 6, 2005 I gave the bill for installing the drywall, \$1,372.80.
