C O M P L A I N T

NOW COMES the Plaintiff, Glenn F. Schuch, and by his attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff is Glenn F. Schuch, an individual, who currently resides at 870 Treasure Lake, DuBois, Pennsylvania 15801.

2. That the Defendant is Staci A. Rieder, an individual, who currently resides at Box 1021 Treasure Lake, DuBois, Pennsylvania 15801.

4. That on December 24, 2000, Plaintiff proposed marriage to the Defendant, and Defendant accepted his proposal.

5. That as a result, Plaintiff presented Defendant with a diamond engagement ring and the parties became engaged.

6. That the appraisal value of the ring is \$23,325.00. (Plaintiff's Exhibit A.)

10. That Plaintiff is entitled to the return of the diamond engagement ring as it was conditioned upon a marriage between Plaintiff and Defendant that never took place.


WHEREFORE, Plaintiff requests your Honorable Court to order the Defendant to return the diamond engagement ring to the Plaintiff.
