## COMPLAINT

1. Plaintiff, Onyx Investment, L.L.C., is a limited liability company having offices in Oklahoma City, Oklahoma.

2. Plaintiff, Eagle Credit Resources, L.L.C., is a limited liability company whose address is 8321 East 61<sup>st</sup> Street, Suite 108, Tulsa, Oklahoma, and, as the assignee of the rights of Advanta Bank Corporation, stands in its assignor's stead, and both are hereinafter referred to interchangeably as "Plaintiff". A true and correct copy of the Bill of Sale between Eagle Credit Resources, L.L.C. and Advanta Bank Corporation, is attached hereto, marked as Exhibit "1" and made a part hereof.

3. Plaintiffs, Onyx Investment, L.L.C. and Eagle Credit Resources, L.L.C., entered into an Investment Agreement, and are both hereinafter referred to interchangeably as "Plaintiff". A true and correct copy of the agreement is attached hereto, marked Exhibit "2", and made a part hereof.

4. Defendant is an individual engaged in business at 45 Rocky Bend Road, Clearfield, Clearfield County, Pennsylvania 16830.

5. As Pleasant Hills Apartments is an unregistered fictitious name, Plaintiff brings this action pursuant to P.A.R.C.P. 2128(d).

6. On or about November 27, 1999, Defendant applied for and received an Advanta Bank Business Mastercard credit card issued by Plaintiff, bearing the account number 5477 5314 1860 0018. A true and correct copy of the application is attached hereto, marked Exhibit "3", and made a part hereof.

7. By accepting and using the aforesaid MasterCard, Defendant agreed to all of the terms and conditions set forth in the Cardholder Agreement that was provided to Defendant with the issuance of said credit card. A true and correct copy of the Terms and Conditions of the cardholder agreement is attached hereto, marked as Exhibit "4", and made a part hereof.

8. Defendant made use of said credit card and, as of December 30, 2004, had a balance due and owing to Plaintiff in the amount of \$18,737.45. A true and correct copy of Plaintiff's Statement of Account is attached hereto, marked as Exhibit "5", and made a part hereof.

9. Defendant is in default of the terms of the cardholder Agreement, having not made payment to Plaintiff as promised, thereby rendering the entire balance immediately due and payable.

10. Plaintiff avers that the Agreement between the parties provides that Plaintiff is entitled to a Late Payment fee of \$39.00.

11. Plaintiff avers that the Agreement between the parties provides that Plaintiff is entitled to the addition of interest at the rate of 29.99% per annum and late charges on the unpaid balance.

12. Plaintiff avers that interest at the aforesaid rate from December 30, 2004 to May 11, 2006 amounts to \$7,655.87.

13. Despite Plaintiff's repeated requests for payment, Defendant has failed to and/or refused to pay the aforesaid balance, interest, or any part thereof to Plaintiff.

WHEREFORE, Plaintiff requests Judgment in its favor and against Defendant in the amount of \$26,393.32, plus ongoing interest at the rate of 29.99% from May 12, 2006 and costs.
