SERVICE OF NOTICE OF APPEAL AND OTHER DOCUMENTS FROM APPEAL  
FROM A DISTRICT JUSTICE DECISION

- (1) The Prothonotary shall require that in regard to any appeal from a District Justice civil decision that the appellant provide with the Notice of Appeal a stamped envelope, pre-addressed to the appellee, at the appellee's address as listed on the Complaint form filed in the office of the District Justice or as otherwise appearing in the records from that office, or the attorney of record, if any, of the appellee, as well as a stamped envelope, pre-addressed, to the District Justice in whose office the judgment was rendered. Copies of the Notice of Appeal, and Rule to File a complaint pursuant to Rule of District Justice Procedure 1004B, if applicable, shall thereupon be mailed by the Prothonotary by first class mail to the appellee and District Justice.
- (2) The Prothonotary shall note such service and any return thereof on the Court's docket.
- (3) The Prothonotary shall not be required to file a Notice of Appeal to a District Justice judgment or verdict without the appellant providing the above described stamped and addressed envelopes for service purposes.
- (4) At the conclusion of any District Justice civil case, upon rendering of the decision, the District Justice shall provide a copy of this Rule to the party against whom the judgment or verdict is rendered, with the same either being made when applicable by personal service or through the mail along with the notice of entry of judgment or verdict.
- (5) Upon the Court of Common Pleas disposing of the appeal from a District Justice decision, the Prothonotary shall in all cases utilize the Common Pleas notification request form, prepared by the Administrative Office of Pennsylvania Courts (being AOPC Form 729B-98 or any future revision of the same) in order to notify the District Justice of the result of the appeal. The Prothonotary shall also provide to the District Justice a copy of the Court Order or document which is dispositive of the case.





AND NOW, comes the Plaintiff, McLean Publishing Company, by its attorneys, Hanak, Guido and Taladay, and hereby replies to the New Matter of Defendant Deborah J. Clark as follows:

Paragraphs 1 through 7 of Plaintiff's Complaint are incorporated by reference as if set forth in full.

8. Denied as stated. Defendant, Deborah Clark, came into McLean Publishing Company's Jeffers Street location on February 3, 2005 to place an ad on the weekly NASCAR page. Carrie Kielbowick, Sales Ad Rep, accepted partial payment on the day that Ms. Clark placed the ad and also asked Ms. Clark if she would like to be involved in the annual Daytona 500 Contest. Ms. Clark accepted that and paid for the contest along with part of the first month of her advertisement on the NASCAR page, in the amount of \$65.00. Ms. Clark brought another payment into the McLean Publishing Company offices on February 9,

2005 to pay for the rest of the February advertisements on the NASCAR page - Check No. 1193 for \$30.00. McLean Publishing's general practice with new advertisers is to request pre-payment for the first two months of advertising to establish a track record of payments and to establish a relationship to provide credit for billing.

9. Denied as stated. Carrie Kielbowick, Ad Sales Rep, contacted Ms. Clark to arrange for payment for NASCAR COLLECTIBLES ad on the NASCAR page for the second month of its advertising run in March, 2005. Ms. Clark made a payment by check No. 1215 for \$40.00 on March 2, 2005.

10. Denied as stated. When Ms. Clark made her payment on March 2, 2005 for the NASCAR COLLECTIBLES ad for the March, 2005 NASCAR page, she provided that payment to one of McLean Publishing Company's Ad Designers as Ms. Kielbowick was not in the office at that time. McLean Publishing Company Ad Designers do not discuss the advertising requirements with the advertisers, nor advise payment requirements, as that is not within their job function nor within their breadth of knowledge to discuss those issues. Ms. Kielbowick did not contact Ms. Clark as the advertisement was set up, on the front side, as a "Till Further Notice" ad and we were not advised to stop running the ad.

11. After reasonable investigation, Plaintiff is without information sufficient to form a belief as to the truth of the averments of


