



EXHIBIT "A"

ALL that certain tract of land being Lot 1 of the Rob and Theresa Fye Subdivision and being situate in the Township of Graham, County of Clearfield and State of Pennsylvania said tract being a part of a tract of land as shown on a deed recorded as Instrument Number 200410494 in the Office of Records, Clearfield County, Pennsylvania, said Lot-1 being more particularly described as follows:

BEGINNING at an iron pin in the centerline of Pennsylvania Route 2033 said iron pin being S 37° 05' 04" W a distance of one hundred seventy six and 61/100 feet (176.61 feet) from the northwest corner aforesaid tract of land as shown on a deed recorded as Instrument Number 200410494; thence through the lands of now or formerly, Robert and Theresa Fye, S 57° 41' 47" E a distance of six hundred ninety three and 69/100 feet (693.69 feet) to an iron pin; thence along same S 00° 30' 27" W a distance of four hundred eighty six and 44/100 feet (486.44 feet) to an iron pin on the line of land of now or formerly Jonathan Emigh Heirs; thence along the line of land of said Jonathan Emigh Heirs, N 89° 29' 33" W a distance of six hundred forty and 32/100 feet (640.32 feet) to an iron pin; thence along same N 00° 30' 31" E a distance of seven hundred sixty five and 78/100 feet (765.78 feet) to a point at the centerline of aforesaid Pennsylvania Route 2033; thence along said centerline the following two courses and distances, N 30° 46' 36" E a distance of seventy one and 76/100 feet (71.76 feet) to a point; thence along same along a curve to the right having a radius of one thousand fifty nine and 55/100 feet (1059.55 feet), a delta angle of 01° 31' 38", a chord bearing of N 31° 32' 24" E, a chord distance of twenty eight and 24/100 feet (28.24 feet) a arc distance of twenty eight and 24/100 feet (28.24 feet) to the point of beginning.

CONTAINING 435,600.00 square feet or 10.00 acres and being designated as Lot-1 of the Rob and Theresa Fye Subdivision on a map prepared by GeoTech Engineering, Inc., dated May 1, 2006, and recorded May 18, 2006, in the Clearfield County Recorder's Office at Instrument No. 200607659.
