

Petition to Compel Compliance with Order of Department

AND NOW COMES the Commonwealth of Pennsylvania, Department of Environmental Protection (hereinafter referred to as "the Department"), pursuant to 35 P.S. §§ 6018.104(10) and 6018.603, who files this Petition to Compel Compliance with Order of Department. In support thereof, the Department respectfully represents as follows:

1. Your Petitioner, the Department, is the Administrative agency with the authority and responsibility to administer and enforce the Solid Waste Management Act, the Act of July 7, 1980, P.L. 380, *as amended*, 35 P.S. §§ 6018.101 *et seq.* ("SWMA"); The Clean Streams Law, Act of June 22, 1937, P.L. 1987, as amended, 35 P.S. §§ 691.1 *et seq.* ("Clean Streams Law"); the Hazardous Sites Cleanup Act, the Act of October 18, 1988, P.L. 756, No. 1988-108, 35 P.S. § 6020.101 *et seq.*; Section 1917-A of the Administrative Code of 1929, Act of April 9, 1929, P.L. 177, *as amended*, 71 P.S.

§ 510-17 (“Administrative Code”); and the rules and regulations promulgated thereunder.

2. Respondent James Hile, (“Hile”) is a person as that term is defined in Section 103 of the SWMA, 35 P.S. § 6018.103. Hile’s mailing address is RD 1, Box 318, Clearfield, PA 16830.

3. This Court has jurisdiction over this proceeding pursuant to Sections 761 and 931 of the Judicial Code, 42 Pa. C.S.A. §§ 761 and 931.

4. Pursuant to the SWMA at 35 P.S. § 6018.602, on December 5, 2005 the Department issued an Enforcement Order against Hile (hereinafter “Enforcement Order”). The December 5, 2005 Enforcement Order is incorporated herein by reference as though fully set forth, and a copy is attached hereto marked as “Exhibit A”.

5. On January 4, 2006 Department employee James D. Greene personally served Hile with the Enforcement Order.

6. Pursuant to 25 Code § 1021.52(a)(1), Hile had thirty (30) days after receipt of the Enforcement Order in which to file an appeal with the Environmental Hearing Board (“EHB”), or by February 6, 2006.

7. As documented in an EHB Certification of Official Records dated April 14, 2006, Hile did not file an appeal of the Enforcement Order with the EHB by February 6, 2006. *See* Certification of Official Records attached hereto marked as “Exhibit B” and incorporated herein by reference as though fully set forth.

8. Because Hile did not appeal the Enforcement Order, he is precluded from

contesting its content or validity in this proceeding. *DER v. Wheeling-Pittsburgh Steel Corp.*, 473 Pa. 432, 375 A.2d 320 (1977); *DER v. Williams*, 57 Pa. Cmwlth. 8, 425 A.2d 871 (1981).

9. The following facts and violations are conclusively established by the Enforcement Order:

- a. James Hile maintains a mailing address of RD 1, Box 318, Clearfield, PA 16830.
- b. Hile owns approximately 19.96 acres on Flegal Road in Lawrence Township, Clearfield County, identified in the Clearfield County Tax Assessment Office as Tax Parcel Number 123-K07-00041 (hereinafter referred to as "Site A") and approximately six (6) acres on the Martin Street Extension where an office and recycling building are located in Lawrence Township, Clearfield County, identified in the Clearfield County Tax Assessment Office as Tax Parcel Numbers J08-000-00165 and J08-000-00165 (hereinafter referred to as "Site B").
- c. On July 16, 2003, the Department conducted an inspection at Site A. At that time it was determined that Hile had deposited onto the ground at the Site approximately 3,000 waste tires in violation of Section 6018.610(1) of the SWMA, 35 P.S. § 6018.610(1), for dumping or depositing solid waste onto the surface of the ground without a permit and Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), for operating a solid waste storage or disposal facility without a permit.
- d. On March 9, 2004, the Department conducted an inspection at Site A. No tires had been removed from the Site since the initial inspection on July 16, 2003.
- e. On March 29, 2004, the Department issued Hile a Notice of Violation (NOV) for violations observed at Site A during the March 9, 2004 inspection. Hile was found in violation of Section 6018.610(1) of the SWMA, 35 P.S. § 6018.610(1), for dumping or depositing solid waste onto the ground without a permit and Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), for operating a solid waste storage or disposal facility

without a permit. The Department recommended that Hile come into compliance at the Site by removing all waste tires from the Site to a permitted processing facility by August 30, 2004 and retain all receipts from the tire removal for review by the Department.

- f. On July 8, 2005, the Department conducted an inspection at Site A. The waste tires remained on the Site. No tires had been removed from the Site since the initial inspection of July 16, 2003. Hile was in violation of Section 6018.610(1) of the SWMA, 35 P.S. § 6018.610(1), for dumping or depositing solid waste onto the surface of the ground without a permit and Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), for operating a solid waste disposal facility without a permit.
- g. On October 26, 2005, an inspection conducted by the Department at Site B revealed that non-marketable recyclable materials including brown beer bottles, clear glass beakers, clear glass bowls and plastic sheeting are being buried on site. The dumping and burial area is approximately 50 feet by 15 feet and 6 feet deep. The Department has estimated at least 30 tons of waste is disposed of in this pile. There was also a burn area consisting of approximately thirty (30) 5-gallon paint buckets, thinner buckets, wood and paper.
- h. On or about October 30, 2005, a tire fire occurred at Site A off Flegal Road in Lawrence Twp. Approximately 1/2 of the 3,000 tires were burned. It was not determined how the fire started.
- i. Hile has never applied for nor received a permit from the Department to burn, dump, dispose of or deposit solid waste onto the surface of the ground at Site A or Site B.
- j. Under Section 103 of the Solid Waste Management Act, 35 P.S. § 6018.103, the definition of "disposal" provides in part, that the storage of any waste in excess of one year constitutes disposal.
- k. Section 610(1) of the SWMA, 35 P.S. § 6018.610(1), states, in part that: "It shall be unlawful for any person or municipality to ...[d]ump or deposit, or permit the dumping or depositing, of any solid waste onto the surface of the ground...unless a permit for the dumping of such solid wastes has been obtained from the [D]epartment...".

1. Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), in part states, that: "It shall be unlawful for any person or municipality to ...[c]onstruct, alter, operate or utilize a solid waste storage, treatment, processing or disposal facility without a permit from the [D]epartment as required by this act or in violation of the rules or regulations adopted under this act, or orders of the [D]epartment, or in violation of any term or condition of any permit issued by the [D]epartment."
- m. Section 610(3) of the SWMA, 35 P.S. § 6018.610(3), in part states, that: "It shall be unlawful for any person or municipality to ...[b]urn solid wastes without a permit from the [D]epartment."
- n. The conditions described in [Subparagraphs 9c, d, e, f and g], above, constitute violations of Sections 610(1) and 610(2) of the SWMA, 35 P.S. § 6018.610(1), and § 6018.610(2).
- o. The conditions described in [Subparagraphs 9f and g], above, constitute violations of Section 610(3) of the SWMA, 35 P.S. § 6018.610(3).
- p. The violations described in [Subparagraphs 9n and o], above, constitute unlawful conduct under Section 610 of the Solid Waste Management Act, 35 P.S. § 6018.610; a statutory nuisance under Section 601 of the SWMA, 35 P.S. § 6018.601; and subject Hile to civil penalty liability under Section 605 of the SWMA, 35 P.S. § 6018.605.

10. Pursuant to 35 P.S. § 6018.602(a), the Enforcement Order was effective as of the day of receipt of the Enforcement Order: January 4, 2006.

11. The Enforcement Order required Hile to:

- (a) Effective [upon receipt of the Order, January 4, 2006], not accept, store or dispose of any solid waste at Site A or Site B including waste tires, non-marketable recyclable items, glass, paper or wood.
- (b) Effective [upon receipt of the Order, January 4, 2006], not burn any solid

waste on Site A or Site B including paper, wood or waste tires.

(c) Within 60 days of receipt of the Order [by March 6, 2006], remove all solid waste, including but not limited to waste tires, waste non-marketable recyclable items, burned waste and other solid waste disposed of or buried at the two sites, for processing or disposal at a permitted or approved waste disposal or waste processing facility. Such removal shall be in compliance with all applicable state and federal statutes, rules and regulations.

(d) Submit to the Department all receipts indicating that all solid waste and recyclable materials found at Site A and Site B have been properly processed or disposed of at permitted disposal and processing facilities. The receipts must be submitted within 67 days after Hile's receipt of the Order [by March 13, 2006].

12. On March 7, 2006 the Department conducted an inspection of the facility at Martin Street Extension ("Site B") and observed that

(a) Burning had stopped;

(b) Waste tires that had been removed from Flegal Street ("Site A") were taken to Site B and placed in a building;

(c) The waste glass that had been dumped over the bank had not been recovered, and additional glass had been dumped over the bank since the October 26, 2005 inspection.

13. On April 4, 2006 the Department conducted an inspection of the facility at Martin Street Extension ("Site B") and observed that a portion of the brown glass that was dumped over the bank has been recovered and piled at the western end of the Site mixed with dirt. Some partially buried glass, plastics and some metal items remained on top of and over the bank.

14. On May 24, 2006 the Department conducted an inspection of the facility at Martin Street Extension ("Site B") and observed that:

- (a) Some of the waste glass and metal that had been dumped over the bank had been removed, but the glass had been piled at the west end of the property;
- (b) There still was buried glass, metal and plastic over the bank behind the building; and
- (c) There was a large pile of cardboard and wooden pallets behind the building.

14. The conditions observed on March 7 and May 24, 2006 at Hile's facility at Martin Street Extension ("Site B") are in direct violation of the Department's Enforcement Order.

15. To the date of the filing of this Petition, the Department has not received any receipts indicating that all solid waste and recyclable materials found at Site A and Site B have been properly processed or disposed of at permitted disposal and processing facilities.

WHEREFORE, the Department respectfully requests that this Honorable Court:


1. Enter the attached Rule to Show Cause;
2. After hearing, pursuant to 35 P.S. § 6018.603, order Hile to immediately stop accepting or disposing of any solid waste at his facilities in Lawrence Township, Clearfield County at Flegal Road (“Site A”) and Martin Street Extension (“Site B”);
3. After hearing, pursuant to 35 P.S. § 6018.603, order Hile, within fifteen (15) days of the date of hearing, to:
 - a. Remove from his facility in Lawrence Township, Clearfield County at Martin Street Extension (“Site B”) all solid waste, including but not limited to waste tires, waste non-marketable recyclable items, burned waste and other solid waste disposed of or buried at the two sites, for processing or disposal at a permitted or approved waste disposal or waste processing facility. Such removal shall be in compliance with all applicable state and federal statutes, rules and regulations and
 - b. Submit to the Department any and all receipts and other documentation such as invoices, waste manifests, and bills of lading confirming all solid waste at Site B was processed or disposed of properly and legally.
4. After hearing, pursuant to 35 P.S. § 6018.603, Order that Hile pay a fine of \$50.00 per day for each day he fails to comply with this Court’s Order, with costs to be calculated at the time of any finding of contempt by this Honorable Court;
5. Find that the facts and violations set forth in the December 5, 2005 Enforcement Order are conclusively established;

6. Grant the Department attorney's fees and costs;
7. Order such other relief that the Court deems just and proper; and
8. Retain continuing jurisdiction of this matter.



ORDER

AND NOW, this 5th day of December 2005, the Commonwealth of Pennsylvania Department of Environmental Protection (hereinafter referred to as "Department") has determined that:

A. The Department is the Administrative agency with the authority and responsibility to administer and enforce the Solid Waste Management Act, the Act of July 7, 1980, P.L. 380, *as amended*, 35 P.S. §§ 6018.101 *et seq.* ("SWMA"); The Clean Streams Law, Act of June 22, 1937, P.L. 1987, as amended, 35 P.S. §§ 691.1 *et seq.* ("Clean Streams Law"); the Hazardous Sites Cleanup Act, the Act of October 18, 1988, P.L. 756, No. 1988-108, 35 P.S. § 6020.101 *et seq.*; the Air Pollution Control Act, Act of January 8, 1960, P.L. 2119 (1959), *as amended*, 35 P.S. §§ 4001 *et seq.*; Section 1917-A of the Administrative Code of 1929, Act of April 9, 1929, P.L. 177, *as amended*, 71 P.S. § 510-17 ("Administrative Code"); and the rules and regulations promulgated thereunder.

B. James Hile maintains a mailing address of RD 1, Box 318, Clearfield, PA 16830.

C. Hile owns approximately 19.96 acres on Flegal Road in Lawrence Township, Clearfield County, identified in the Clearfield County Tax Assessment Office as Tax Parcel Number 123-K07-00041 (hereinafter referred to as "Site A") and approximately 6 acres on the Martin Street Extension where an office and recycling building are located in Lawrence Township, Clearfield County identified in the Clearfield County Tax Assessment Office as Tax Parcel Numbers J08-000-00165 and J08-000-00165 (hereinafter referred to as "Site B").

D.

1. On July 16, 2003, the Department conducted an inspection at the Site A. At that time it was determined that Hile had deposited onto the ground at the site approximately 3,000 waste tires in violation of Section 6018.610(1) of the SWMA, 35 P.S. § 6018.610(1), for dumping or depositing solid waste onto the surface of the ground without a permit and Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), for operating a solid waste storage or disposal facility without a permit.

2. On March 9, 2004, the Department conducted an inspection at the Site A. No tires had been removed from the site since the initial inspection on July 16, 2003.

3. On March 29, 2004, the Department issued Hile a Notice of Violation (NOV) for violations observed at Site A during the March 9, 2004 inspection. Hile was found in violation of Section 6018.610(1) of the SWMA, 35 P.S. § 6018.610(1), for dumping or depositing solid waste onto the ground without a permit and Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), for operating a solid waste storage or disposal facility without a permit. The Department recommended that Hile come into compliance at the Site by removing all waste tires from the Site to a permitted processing facility by August 30, 2004 and retain all receipts from the tire removal for review by the Department.

4. On July 8, 2005, the Department conducted an inspection at the Site A. The waste tires remained on site. No tires had been removed from the site since the initial inspection of July 16, 2003. Hile was in violation of Section 6018.610(1) of the SWMA, 35 P.S. § 6018.610(1), for dumping or depositing solid waste onto the surface of the ground without a permit and Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), for operating a solid waste disposal facility without a permit.

5. On October 26, 2005, an inspection conducted by the Department at Site B revealed that non-marketable recyclable materials including brown beer bottles, clear glass beakers, clear glass bowls and plastic sheeting are being buried on site. The dumping and burial area is approximately 50 feet by 15 feet and 6 feet deep. The Department has estimated at least 30 tons of waste disposed of in

this pile. There was also a burn area consisting of approximately thirty 5-gallon paint buckets, thinner buckets, wood and paper.

6. On or about October 30, 2005, a tire fire occurred at Site A off Flegal Road in Lawrence Twp. Approximately 1/2 of the 3,000 tires were burned. It was not determined how the fire started.

E. Hile has never applied for nor received a permit from the Department to burn, dump, dispose of or deposit solid waste onto the surface of the ground at Site A or Site B.

F. Under Section 103 of the Solid Waste Management Act, 35 P.S. § 6018.103, the definition of "disposal" provides in part, that the storage of any waste in excess of one year constitutes disposal.

G. Section 610(1) of the SWMA, 35 P.S. § 6018.610(1), states, in part that: "It shall be unlawful for any person or municipality to ...[d]ump or deposit, or permit the dumping or depositing, of any solid waste onto the surface of the ground...unless a permit for the dumping of such solid wastes has been obtained from the [D]epartment..."

H. Section 610(2) of the SWMA, 35 P.S. § 6018.610(2), in part states, that: "It shall be unlawful for any person or municipality to ...[c]onstruct, alter, operate or utilize a solid waste storage, treatment, processing or disposal facility without a permit from the [D]epartment as required by this act or in violation of the rules or regulations adopted under this act, or orders of the [D]epartment, or in violation of any term or condition of any permit issued by the [D]epartment."

I. Section 610(3) of the SWMA, 35 P.S. § 6018.610(3), in part states, that: "It shall be unlawful for any person or municipality to ...[b]urn solid wastes without a permit from the [D]epartment."

J. The conditions described in Paragraphs D1, D2, D4, D5 and D6, above, constitute violations of Sections 610(1) and 610(2) of the SWMA, 35 P.S. § 6018.610(1), and § 6018.610(2).

K. The conditions described in Paragraphs D5, and D6, above, constitute violations of Section 610(3) of the SWMA, 35 P.S. § 6018.610(3).

J. The violations described in Paragraph J and K, above, constitute unlawful conduct under Section 610 of the Solid Waste Management Act, 35 P.S. § 6018.610; a statutory nuisance under Section 601 of the SWMA, 35 P.S. § 6018.601; and subject Hile to civil penalty liability under Section 605 of the SWMA, 35 P.S. § 6018.605.

NOW, THEREFORE, pursuant to Section 1917-A of the Administrative Code, 71 P.S. § 510-17, Sections 104(7), 601 and 602 of the SWMA, 35 P.S. § 6018.104(7), § 6018.601 and § 6018.602, it is ORDERED as follows:

Cease disposal immediately.

(a) Effective immediately, Hile shall not accept, store or dispose of any solid waste at Site A or Site B including waste tires, non-marketable recyclable items, glass, paper or wood.

Cease burning immediately.

(b) Effective immediately, Hile shall not burn any solid waste on Site A or Site B including paper, wood or waste tires.

Properly dispose of solid waste.

(c) Within 60 days of receipt of this Order, Hile shall remove all solid waste, including but not limited to waste tires, waste non-marketable recyclable items, burned waste and other solid waste disposed of or buried at the two sites, for processing or disposal at a permitted or approved waste disposal or waste processing facility. Such removal shall be in compliance with all applicable state and federal statutes, rules and regulations.

Submit Receipts

(d) Hile shall submit to the Department all receipts indicating that all solid waste and recyclable materials found at Site A and Site B have been properly processed or disposed of at permitted disposal and processing facilities. Receipts shall be sent to the Department at the address noted below. The receipts must be submitted within 67 days after Hile's receipt of this Order. Receipts shall be sent to:

Any person aggrieved by this action may appeal, pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. Section 7514, and the Administrative Agency Law, 2 Pa. C.S. Chapter 5A, to the Environmental Hearing Board, Second Floor, Market Street State Office Building, 400 Market Street, P.O. Box 8457, Harrisburg, PA 17105-8457, (717) 787-3483. TDD users may contact the Board through the Pennsylvania Relay Service, (800) 654-5984. Appeals must be filed with the Environmental Hearing Board within 30 days of receipt of written notice of this action unless the appropriate statute provides a different time period. Copies of the appeal form and the Board's rules of practice and procedure may be obtained from the Board. The appeal form and the board's rules of practice and procedure are also available in Braille or on audiotape from the Secretary to the Board at (717) 787-3483. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.

Petition for Finding of Contempt of Court Order

AND NOW COMES the Commonwealth of Pennsylvania, Department of Environmental Protection (hereinafter referred to as "the Department"), pursuant to 42 Pa. C.S.A § 4132, who files this Petition for Finding of Contempt of Court Order. In support thereof, the Department respectfully represents as follows:

1. Your Petitioner, the Department, is the Administrative agency with the authority and responsibility to administer and enforce the Solid Waste Management Act, the Act of July 7, 1980, P.L. 380, *as amended*, 35 P.S. § 6018.101 *et seq.* ("SWMA"); The Clean Streams Law, Act of June 22, 1937, P.L. 1987, as amended, 35 P.S. § 691.1 *et seq.* ("Clean Streams Law"); Section 1917-A of the Administrative Code of 1929, Act of April 9, 1929, P.L. 177, *as amended*, 71 P.S. § 510-17 ("Administrative Code"); and the

rules and regulations promulgated thereunder.

2. Respondent James Hile, ("Hile") is a person as that term is defined in Section 103 of the SWMA, 35 P.S. § 6018.103. Hile's last known mailing address is RD 1, Box 318, Clearfield, PA 16830.

3. This Court has jurisdiction over this proceeding pursuant to 42 Pa. C.S.A. § 4132.

4. Hile stipulated to the entry of an Order by this Court, with said Order dated August 31, 2006 being entered on September 6, 2006. The Order entered on September 6, 2006 (hereinafter "September 6, 2006 Order") is incorporated herein by reference as though fully set forth, and a copy is attached hereto marked as "Exhibit A".

5. On September 8, 2006 the Department mailed the September 6, 2006 Order to Hile via postage prepaid first class mail. The Certificate of Service, filed with the Court on September 11, 2006, is incorporated herein by reference as though fully set forth, and a copy is attached hereto marked as "Exhibit B".

6. The September 6, 2006 Order required Hile, within thirty (30) days of the date of the Order [by October 10, 2006] to remove from his facility in Lawrence Township, Clearfield County at Martin Street Extension ("Site") all solid waste buried in the embankment behind the building on the Site, for processing or disposal at a permitted or approved waste disposal facility, waste processing facility or recycling facility; and to remove from the Site all waste tires currently existing on the Site and in the building on the Site, for processing or disposal at a permitted or approved waste disposal or waste processing facility.

7. The September 6, 2006 Order required Hile, within thirty (60) days of the date of the Order [by November 6, 2006] to remove from the Site all solid waste already excavated from the embankment behind the building and now stockpiled at the west end of the Site, for processing or disposal at a permitted or approved waste disposal facility, waste processing facility or recycling facility.

8. The September 6, 2006 Order required Hile, within thirty (70) days of the date of the Order [by November 15, 2006] to submit to the Department any and all receipts and other documentation such as invoices, waste manifests, and bills of lading, confirming all solid waste at the Site as referenced [in Paragraphs 6 and 7 hereinabove] was processed or disposed of at a permitted or approved waste disposal facility, waste processing facility or recycling facility.

9. Pursuant to 42 Pa.C.S.A. § 5571, Hile had thirty (30) days after the entry of the September 6, 2006 Order in which to file an appeal with the Superior Court, or by October 6, 2006.

7. Hile did not file an appeal of the September 6, 2006 Order with the Superior Court by October 6, 2006.

8. As of an inspection conducted by Department personnel on October 20, 2006, Hile had not removed any tires from the Site, with the tires remaining inside of a building on the Site and in a roll-off container on the Site; the previously excavated glass stored at the western end of the Site remained; and Hile had not sent to the Department any disposal receipts for waste that had been removed from the Site. The October 20,

2006 Inspection Report is incorporated herein by reference as though fully set forth, and a copy is attached hereto marked as "Exhibit C".

8. As of an inspection conducted by Department personnel on December 13, 2006, Hile had not removed any tires from the Site, with the tires remaining inside of a building on the Site and in a roll-off container on the Site; the previously excavated glass stored at the western end of the Site remained; and Hile had not sent to the Department any disposal receipts for waste that had been removed from the Site. The December 13, 2006 Inspection Report is incorporated herein by reference as though fully set forth, and a copy is attached hereto marked as "Exhibit D".

9. Under the September 6, 2006 Order, this Court retained continuing jurisdiction of this matter.

11. Mr. Hile has demonstrated by his inaction that he has no intention of complying with this Court's September 6, 2006 Order.


WHEREFORE, the Department respectfully requests that this Honorable Court:
