



**COMPLAINT**

**AND NOW**, comes the Plaintiff, **FOLCARELLI SHEET METAL, INC. t/d/b/a FOLCARELLI SUPPLY COMPANY**, by its attorneys, Goldstein, Heslop, Steele, Clapper & Oswalt, and files this Complaint against the Defendant whereof the following is a statement:

1. Plaintiff, **FOLCARELLI SHEET METAL, INC. t/d/b/a FOLCARELLI SUPPLY COMPANY**, is a Pennsylvania corporation having a principal place of business at 4141 Sixth Avenue, Altoona, Blair County, Pennsylvania 16603.
2. Defendant, **WILLIAM D. BEERS t/d/b/a BILL BEERS PLUMBING & HEATING**, is an adult individual residing at and/or having a place of business at 2734 Dillon Road, Coalport, Clearfield County, Pennsylvania 16627.
3. Beginning in September of 2005, Plaintiff and Defendant entered into a course of conduct where Defendant would order certain building products from the Plaintiff and Defendant would agree to pay the Plaintiff for said products.
4. Invoices documenting orders made by the Defendant beginning with an invoice date of September 12, 2005, and ending with an invoice date of November 21, 2005, are attached hereto, incorporated herein by reference as if fully set forth at length, and marked collectively as Exhibit "A".
5. Defendant ordered from the Plaintiff all products identified on the invoices consisting of Exhibit "A" and Defendant agreed to pay the prices set forth on Exhibit "A".

6. All prices set forth on the invoices attached hereto as Exhibit "A" are fair and reasonable charges for the product purchased.
7. All products identified on the invoices attached hereto as Exhibit "A" were delivered on the dates set forth on the invoices.
8. Defendant accepted delivery of all products set forth on the invoices attached hereto as Exhibit "A".
9. Defendant never complained or objected to any of the products delivered as set forth in Exhibit "A".
10. Payment for all items set forth on Exhibit "A" was due 30 days after delivery.
11. The total amount due for products identified on the past-due invoices attached hereto as Exhibit "A" is \$9,548.41.
12. Two credit memos due the Defendant total \$237.12. Deducting this amount from the amount set forth in the preceding paragraph leaves a balance of \$9,311.29.
13. Legal interest on the unpaid balance beginning January 1, 2006, through and including June 30, 2006, is \$279.33.
14. Demand has been made by Plaintiff on Defendant for all of the above amounts, but Defendant has failed to pay.

WHEREFORE, Plaintiff demands judgment against Defendant in the amount of \$9,590.62, plus continuing legal interest at 6 percent from July 1, 2006 forward, plus the costs of this action.
