COMPLAINT

NOW COMES the Plaintiff, Kevin C. Haney, t/d/b/a Haney Building & Remodeling, and by his attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff is Kevin C. Haney, an individual, t/d/b/a Haney Building & Remodeling, who resides at 82 Blackberry Lane, Osceola Mills, Pa. 16666.

2. That the Defendant is Renee Johnson, an individual, who resides at 308 Sheffield Street, Philipsburg, Pa. 16866.

3. That all times alleged herein Defendant was the owner of property and a residential dwelling located at 308 Sheffield Street, Philipsburg, Pa. 16866.

4. That on or about the beginning of the month of

November or December 2005, Defendant contacted Plaintiff via telephone and requested he perform remodeling services on her residential dwelling as described in Paragraph 3.

5. That on or about the latter of the month of November or December 2005, Plaintiff proceeded to the residence of Defendant.

6. That on the date as described in Paragraph 5, Plaintiff met with Defendant and the parties discussed the scope of work to be completed by the Plaintiff for the Defendant.

7. That on the date as described in Paragraph 5, Plaintiff agreed to perform miscellaneous repair work at Defendant's residence on a time and materials basis.

8. That Defendant and Plaintiff understood that Defendant would charge regular hourly rates for hours of labor required plus the cost of materials.

9. That Plaintiff's charge to Defendant for materials was his cost with no mark-up thereon.

10. That Plaintiff commenced work on Defendant's residential dwelling on or about February 24, 2006.

11. That on or about March 10, 2006, Plaintiff presented a Partial Invoice in the amount of \$4,189.00 (Four thousand one hundred and eighty-nine) dollars to the Defendant upon her request. A true and correct copy of which is attached hereto as Exhibit "A."

12. That on or about March 16, 2006, Plaintiff presented a second Partial Invoice in the amount of \$1,433.00 (One thousand four hundred and thirty-three) dollars to the Defendant. Said Invoice was due and payable by March 17, 2006. A true and correct copy of which is attached hereto as Exhibit "B."

13. That on or about April 24, 2006, Defendant responded to Plaintiff with a partial payment of \$500.00 (Five hundred) dollars in the form a check written from her personal checking account. A true and correct copy of which is attached hereto as Exhibit "C."

14. That Defendant made an additional payment to Plaintiff in the amount of \$200.00 (Two hundred) dollars in the form a check written from her personal checking account. A true and correct copy of which is attached hereto as Exhibit "D."

15. That Plaintiff's schedule of labor rates includes three laborers: Brain, Danny and Kevin (the latter is, the Plaintiff Kevin C. Haney).

16. That Plaintiff's schedule of labor as charged to the Defendant is as follows: Brian is charged at the rate of \$20.00 (Twenty) dollars per hour worked, Danny is charged at the rate of \$25.00 (Twenty-five) dollars per hour worked, and Kevin is charged at the rate of \$24.00 (Twenty-four) dollars per hour worked. A true and correct copy of Plaintiff's Labor Schedule

as billed to Defendant is attached as Exhibit "E" (Three columns are listed on this document. One column for each individual charging hours, that is, Brian, Danny and Kevin. Brian is signified as column "B", Danny is signified as column "D" and Kevin is signified as column "K.")

17. That per Plaintiff's Labor Schedule as described in Paragraph 17, as of March 7, 2006 the total labor charge was \$3,800.00 (Three thousand and eight hundred) dollars.


18. That Plaintiff's Partial Invoice generated as of March 8, 2006 incorrectly quoted the total labor charged at this time as \$3542.00 (Three thousand five hundred and forty-two) dollars.

19. That Defendant owes Plaintiff the additional \$258.00 (Two hundred fifty-eight) dollars in labor charges as provided to Plaintiff by the Defendant.

20. That there is presently owing and due the Plaintiff for services and materials rendered the unpaid amount of \$5,180.00 (Five thousand one hundred eighty) dollars.

21. That although a demand has been made, Defendant has failed to pay the sum due as described in Paragraph 20.

WHEREFORE, Plaintiff claims damages from the Defendants in the amount of \$5, 180.00 with costs and interest thereon from March 18, 2006.
