8. Defendants received and accepted said gasoline and petroleum related products and mechanical services.

9. The prices charged for said gasoline and petroleum related products were fair and reasonable and the prices Defendants agreed to pay.


4. The principal sum of \$16,200.70 is currently due and owing to Plaintiff by Defendants.
