WAIVER OF MECHANIC'S LIEN

WHEREAS, THOMAS J. LOMBARDI and JENNIFER L. JOHNSON, of 926 Stone Chapel Road, Westminster, MD 21157, is about to execute contemporaneously herewith, a contract as general contractor with J & R CONSTRUCTION, of 375 Main Street, P.O. This Waiver of Mechanic's Lien is intended to be filed with the Clearfield County Prothonotary within ten (10) days after this date.


