3. Defendant applied for and received a credit card bearing the account number 5291151803687969 .


4. Defendant made use of said credit card and has a current balance due of \$1685.99 , as of July 12, 2006 .

1. **How To Avoid A Finance Charge.**  
†a. **Grace Period.** You will have a minimum grace period of 25 days without finance charge on new purchases, new transfers, new special transfers, and new other charges if you pay your total "New Balance" in accordance with the Important Notice for payments below, and in time for it to be credited by your next statement closing date.
