COMPLAINT FOR PARTITION OF REAL PROPERTY

NOW COMES the Plaintiff, LP Land, LLC, and by their attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff, LP Land, LLC, is a limited liability company, and has its principal place of business at 1124 Lezzer Lane, Curwensville, Pennsylvania.
2. That the Defendant, Samuel J. Serian, is an individual, who was last known to reside at 22 Clinton Street, Rossiter, PA 15772.
3. That the Defendant, Janet Bonita Hartshorn, is an individual, residing at 7 Windsor Drive, Charleston, North Carolina 29407.

4. That the Defendant, Edward K. Eyster, is an individual residing at 1621 SE 8th Street, Cape Coral, Florida 33990.

5. That the Defendants, namely Harold G. Eyster Jr. is an individual last known to be residing at 190 Kings Highway, Altoona, PA 16602.

6. That the Defendants, namely any other heirs and successors in interest to the estate of Harold G. Eyster may or may not exist and are unidentified and whereabouts are unknown.

7. That the Defendants, namely the heirs and successors in interest to the estate of Josephine Edwards are unidentified and whereabouts are unknown.

8. That the Defendants, namely the heirs and successors in interest to the estate of Effie M. Rupert are unidentified and whereabouts are unknown.

9. Plaintiffs and defendants are the owners of certain real estate in Clearfield County as described below, and all the interests of the parties in the property are held as tenants in common and are undivided.

10. The property in question is identified as No. 3579, and is all that certain tract or parcel of land situated in The Township of Bloom (Map No. 104-F7-4), County of Clearfield and State of Pennsylvania. The property is bounded and described as follows:

Beginning at a post, the Southwest corner of tract; thence by tract No. 3610, North four and one-half degrees East one hundred and one (101) perches to point on line of Thomas Currie one hundred and thirty-eight acre tract; thence by said Currie tract South eighty-five and one-half degrees East seventy-nine (79) perches, more or less, to post and stones on West line of right of way of Clearfield & Mahoning Railroad; thence by said right of way line in a Northwesterly direction one hundred and fifty-two (152) perches, more or less, to where the said right of way line intersects the West line North four and one-half degrees East two hundred (200) perches, more or less, to Gum corner of tract; thence by tract No. 3596 South eighty-five and one-half degrees East four hundred and sixteen (416) perches to a Gum on line of tract No. 4252; thence South four and a half degrees West four hundred and sixteen (416) perches to a whiteoak; thence by tract No. 3590 North eighty-five and one-half degrees West four hundred and sixteen (416) perches to the place of beginning, containing one thousand and twenty (1020) acres, more or less, being part of tract No. 3579.

11. That Plaintiffs acquired title to a 37.5 percent undivided interest in the property described above by deeds from two separate grantors, one being the Estate of Charles A. Irvin and one being several heirs and descendants of R. Wilson McNaul, the last recorded conveyance of the same are dated October 26, 2005, recorded in Clearfield County as Instrument No. 200600126; and November 28, 2005, recorded in Clearfield County as Instrument No. 200600125, respectively.

12. That Defendant, Samuel J. Serian, acquired title with his wife, Ruth Carol Serian, to a 25 percent interest in the property described above by deed, the last recorded conveyance of the same from Kim Mowrey Hobba, dated January 14, 1993,

recorded in Clearfield County Deeds and Records Book Volume 1509, Page 431.

13. That Ruth Carol Serian is now deceased causing Samuel J. Serian to be the sole holder of the 25 percent interest acquired by the couple on January 14, 1993, recorded in Clearfield County Deeds and Records Book Volume 1509, Page 431.

14. That Defendants, Janet Bonita Hartshorn, Edward K. Eyster each acquired title to a 4.16 percent share of the property described above by intestate share as heirs and successors in interest to the estate of Olive E. Eyster.

15. That Olive E. Eyster had acquired title to a 12.5 percent interest in the property described above through a devise in the will of James M. Edwards recorded as Estate No. 5704 in Clearfield County Will Book H, Page 399.

16. That the Defendant, Harold G. Eyster, Jr. acquired a representative and intestate share to a 4.16 percent interest in the above described property as an heir and successor in interest to the estate of Harold G. Eyster.

17. That the Defendants, namely any other the heirs and successors in interest to the estate of Harold G. Eyster identities and whereabouts are unknown and may or may not exist as heirs or successors in interest to the estate of Harold G. Eyster.

18. That the unknown heirs and successors in interest of Harold G. Eyster, should any exist, would acquire title to a a representative and intestate share of 4.16 percent interest; the same share of the property described above which Harold G. Eyster had acquired by intestate share as an heir and successor in interest to the estate of Olive E. Eyster.

19. That Defendants, namely the heirs and successors in interest to the estate of Josephine Edwards, identities and whereabouts are unknown and may or may not exist as heirs or successors in interest to the estate of Josephine Edwards.

20. That the unknown heirs and successors in interest of Josephine Edwards, should any exist, would acquire title to a 12.5 percent interest in the property described above from the estate of Josephine Edwards upon her death.

21. That both Elmer and Josephine Edwards are believed to be deceased.

22. That Elmer and Josephine Edwards had acquired title to a 12.5 percent interest as tenants by the entireties: the last recorded deed of which is recorded in Clearfield County Deeds and Records Book Volume 500, Page 486.

23. That Elmer Edwards is believed to have predeceased Josephine Edwards causing her to be the sole owner of the 12.5 percent interest, the last recorded deed of which is recorded in Clearfield County Deeds and Records Book Volume 500, Page 486.

24. That the unknown heirs and successors in interest of Effie M. Rupert, should any exist, would acquire a representative share in title to a 12.5 percent interest in the property described above from the estate of Effie M. Rupert upon her death.

25. That Effie M. Rupert is believed to be deceased.

26. That Effie M. Rupert had acquired title to a 12.5 percent interest in the property described above by giving effect to a clause in the will of James M. Edwards which provided she receive an intestate share of his property upon her remarriage, recorded in Estate No. 5704 in Clearfield County Will Book H, Page 399.

27. That no other person other than those named as known or those named as unknown has any title or interest in the property.


28. No partition or division of the above-described property has ever been made.

AFFIDAVIT PURSUANT TO PA. R.C.P. 430

1. Counsel for Movant has been unable to determine the identity of the following potential defendants: the heirs and successors in interest to the estates of Josephine Edwards, Harold G. Eyster, and Effie M. Ruppert.

2. Movant and Counsel for Movant have made the following attempts to identify defendants, the potential heirs and successors in interest to the estate of Josephine Edwards:

A. Counsel has spoken to one Edward Eyster, a relative, who confirmed that Josephine Edwards died without children, but could not state conclusively whether any

other possible relatives of Josephine Edwards may or may not have been living at her death.

7. That the Master obtained an appraisal and requested payment from the represented parties through their counsel.

8. That Plaintiff and Defendant, Samuel J. Serian have each paid their share (each has paid 1/3 of the total fee) of the appraisal fee as requested by the Master.

9. That Defendants, Edward K. Eyster, Janet Bonita Hartshorn, Mary Eyster and Kevin Eyster, have refused to pay their share of the appraisal fee.


MOTION FOR CONTINUANCE




