



PETITION FOR CONTEMPT

AND NOW, comes DENNIS P. SHAW and SHIRLEY A. SHAW, Petitioners, by and through their attorneys, NEISWENDER AND KUBISTA, and sets forth the following Petition for Contempt:

1. That the Plaintiffs are Dennis P. Shaw and Shirley A. Shaw, adult individuals, currently residing at 15 Mc Cann Bottom Road, Grampian, Clearfield County, Pennsylvania 16838 (Hereinafter, "Grandparents").
2. That the Defendant is Casey L. Bloom, now known as Casey L. Siegal, an adult individual, currently residing at 2556 Route 28 North, Brookville, Jefferson County, Pennsylvania 15825 (Hereinafter, "Mother").
3. That the Petitioners are the paternal great-grandparents of one child, namely, Ethan Foster Bloom, born October 18, 2005.
4. That the Respondent is the natural mother of the above mentioned minor child.
5. That the natural father is not known inasmuch as the suspected father established his non-paternity through testing at the Domestic Relations Office.

6. That pursuant to the Order of Court dated August 4, 2006, Petitioners and Respondent share joint legal and physical custody of the minor child. *See Attached Exhibit "A".*

7. That from November 1, 2005 to July of 2010, the Petitioners were the primary caretakers of the minor child due to the Respondent's failure to maintain a residence.

8. That in accordance with their role as primary caretakers, Petitioners exclusively handled said minor child's medical needs, expense needs, scholastic and educational needs, and church-related activities.

9. That Mother's active involvement in the United States Army has required that she travel to a number of different states throughout the United States and during these extended leaves, Petitioners have reinforced their position as the primary caretakers of said minor child.

10. That on July 1, 2010, Respondent took the minor child from the Petitioners with the verbal agreement that the parties would still share physical custody of the minor child.

11. That since July of 2010, the Respondent has refused to allow the Petitioners shared custody.

12. That Respondent has only allowed a minimal amount of visitation with no overnights.

13. That since July of 2010, Mother has taken the minor child out of Pre-Kindergarten with Cen-Clear, taken the child outside in thirteen (13) degree temperatures with no coat, and has mentally abused the child.

14. That Petitioners fear that Mother will transport the child out of the state of Pennsylvania.

15. That Respondent has failed to abide by the terms of the Custody Order dated August 4, 2006.

WHEREFORE, Petitioner requests Your Honorable Court to find Respondent in contempt of the Court Order dated August 4, 2006 and issue such sanctions and penalties upon the Petitioner as the Court deems appropriate, including a fine and/or incarceration and modify the Custody Order dated August 4, 2006.

WHEREAS, since November 1, 2005, Casey L. Bloom and her son, Ethan Foster Bloom (d.o.b. 10/18/05), have resided with Dennis P. Shaw and Shirley A. Shaw, and

WHEREAS, Dennis P. Shaw and Shirley A. Shaw have been active caretakers and participants in the life of Ethan Foster Bloom, and

WHEREAS, the parties wish to establish custodial rights reflecting that sharing of care and responsibility.

THEREFORE, THE PARTIES DO AGREE AS FOLLOWS:

1. That this Stipulation shall be incorporated into an Order of Court establishing custody of Ethan Foster Bloom (d.o.b. 10/18/05).


2. That Casey L. Bloom and Dennis P. Shaw and Shirley A. Shaw shall enjoy joint legal and physical custody of Ethan Foster Bloom (d.o.b. 10/18/05).

3. That for purposes of this Stipulation and Agreement, joint legal custody shall be described as follows:


(a) The Court follows the definitions provided by Pa. R.C. P. 1915.1(b) which states that "legal custody means the legal right to make major decisions affecting the best interest of the minor child, including but not limited to, medical, religious and educational decisions", and wherein each of the parties listed herein shall have equal access to any and all medical, dental, school and legal records. Medical and dental

providers – as well as school administrations – shall accept this Order as authorization to release documentation to each individual named herein. In addition, it is understood by all parties herein that they shall communicate fully with the other in an effort to assure that all directives pertaining to the minor child from physicians, dentists and teachers are followed absolutely and all information pertaining to any prescriptions the child is on is exchanged between the parties.


(b) That the parties shall between and among the three of them, establish physical custody of the child as stipulated the day and year first above written, with the intention of this Stipulation and Agreement being incorporated into a Custody Agreement.




