## NO LIEN CONTRACT AGREEMENT

WHEREAS, McCloskey Homes Inc, Principal Contractor had entered into a Construction Contract with R. Michael Love and Jordan N. Love, wife and husband, referred to as ("Owner") to build a single family residence on property located in the Township of Sandy, County of Clearfield, and Commonwealth of Pennsylvania being more particularly described as follows:

NOW THEREFORE, it is hereby stipulated and agreed by and between the parties, as part of said Contract for the consideration set forth that this is a No-Lien Contract and that neither the Contractor nor any Subcontractor, nor any person, firm or corporation furnishing material or labor in the renovation of said building, alterations, and improvements, shall have any right to file Mechanic's or other lien and Contractor hereby waives and releases all lien or right of lien for work done or material furnished under this Contract. If required by Owner, the Contractor shall furnish to Owner a Release of Lien form every person, firm or corporation under direct contract with the Contractor, doing work or furnishing material for the renovation of said building and improvements.

This stipulation is made and intended to be filed with the County Prothonotary within ten (10) days after date in accordance with the requirements of the Acts of Assembly of Pennsylvania in such cases provided.
