3. Defendant applied for and received a credit card bearing the account number 5178052141941654 .


4. Defendant made use of said credit card and has a current balance due of \$2524.98 , as of August 11, 2006 .





**STIPULATION OF THE PARTIES FOR PAYMENT
AND FOR THE ENTRY OF JUDGMENT BY CONSENT**

TO THE PROTHONOTARY:

Kindly enter Judgment in favor of Plaintiff and against the Defendant, JAN S PALMER , above-named, in the amount of \$2,570.65 pursuant to the Stipulation of the Parties for Payment and for the Entry of Judgment by Consent, as follows:

1. Defendant admits indebtedness to Plaintiff in the amount of \$2,570.65 with continuing interest thereon at a rate of 6% per annum plus costs from SEPTEMBER 26, 2006.
2. To secure the repayment of said indebtedness, Defendant agrees that Judgment by Consent will be entered in favor of the Plaintiff and against the Defendant, JAN S PALMER , in the amount of \$2,570.65 plus continuing interest thereon at the rate of 6% per annum from SEPTEMBER 26, 2006 and costs.
3. Plaintiff agrees not to execute on its Judgment so long as Defendant causes to be delivered to Plaintiff the following payments in full by 12:00 NOON on the following dates:
 - (a) \$100.00 due by OCTOBER 30, 2006;
 - (b) \$100.00 due on the 30TH day of each consecutive month thereafter until FEBRUARY 30TH, 2007 then \$150.00 will be due every 30th from March until the Judgment amount plus accrued interest and costs are paid in full.

4. All payments are to be made payable to the order of " CAPITAL ONE BANK "

5. All payments due under this agreement are to be received at the offices of Weltman, Weinberg & Reis, Co., L.P.A., 2718 Koppers Building, 436 Seventh Avenue, Pittsburgh, PA 15219.
