On or about February 17, 2006, Plaintiff and Defendant entered into a Settlement Agreement to settle a dispute regarding a consumer loan debt owed by Defendant to Plaintiff. (Settlement Agreement attached hereto as Exhibit "A".) Under the Settlement Agreement, Defendant was to make monthly payments to Plaintiff. Defendant stopped making payments, resulting in a default in the terms of the Settlement Agreement. As a result of Defendant's breach of the Settlement Agreement, there is due and owing under the terms of the agreement \$5,727.87, plus court costs. 
