COMPLAINT

AND NOW comes, Brian R. Grubbs, by and through his attorney, Girard Kasubick, Esq., and files the following Complaint:

1. The Plaintiff is Brian R. Grubbs, who resides at 327 B Kenmore Drive, Hampton, VA 23661.
2. The Defendants are Louis Erickson a/k/a Lars Erickson a/k/a Lars Erickson Flodin and Christina Erickson a/k/a Christina Erickson Flodin; Martha

Christina Erickson Flodin; and Steve Hovan a/k/a Steve Hovan a/k/a Steve Hovanec and Anna Hovan a/k/a Anna Hoban a/k/a Anna Hovanec, his wife, and their heirs, executors, administrators, successors, trustees, and assigns, known or unknown, and any other person who may claim title under them, and who are deceased or their whereabouts are unknown.

3. The real property involved in and subject of this action is the real property or parcel of land situated in Morris Township, Clearfield County, Pennsylvania, bounded and described as follows:

BEGINNING at a post on line of a sixteen foot alley; thence along said alley South eighty-nine degrees East one hundred and two and five tenths (102.5) feet to post; thence by said alley and lands of Alex Larson, North three degrees and thirty minutes West one hundred and eighty-six feet (186) to post; thence by another alley South eighty-five degrees and thirty minutes West eighty-seven and six tenths (87.6) feet to post; thence by lands of August Bloomquest (now Hovan) South thirty minutes East one hundred and eighty-five and eight tenths (185.8) feet to post and point of beginning. CONTAINING four hundred and five one thousands of one acre.

The above property is a part of Clearfield County Tax Map No. 124-R09-543-13. The above property hereinafter referred to as "Premises".

4. The deeds and method by which Brian R. Grubbs obtained title to the real property described in Paragraph 3 above of this Complaint is as follows:

a). The Premises was conveyed to Brian R. Grubbs by deed from Patti L. Grubbs dated October 2, 2000

and recorded in Clearfield County Instrument No. 200016288. The Premises is the Third Thereof tract described in said deed and the description is a part of Tax Map No. 124-R09-543-13. This deed conveyed all interests of Patti L. Grubbs.

b). The Premises was conveyed to Brian R. Grubbs and Patti L. Grubbs, his wife, by deed from Patricia A. Hovan, Administrator of the Estate of George Hovan a/k/a George Chovenac a/k/a George Chovenec a/k/a George Hovanec and Patricia Hovan, single, dated June 29, 1984 and recorded in Clearfield County Deed Book 956, Page 213. The Premises is the Third Thereof in this deed.

c). George Hovan a/k/a George Chovenac a/k/a George Chovanec a/k/a George Hovanec died November 26, 1983. His Estate is in Clearfield County Estate File No. 83-423 and it shows that he owned a house and lot in Morris Township which is averred to be Tax Map No. 124-R09-543-13 of which the Premises herein is a part. Letters of Administration in this Estate were granted to Patricia E. Hovan, the sole heir of the Estate, who was the daughter of George Hovan.

d). The Premises subject of this action was devised to George Hovan in the Estate of Anna Hovan, who died June 10, 1968 as shown in Clearfield County Estate

File No. 27554. The Will of Anna Hovan in Will Book 13, Page 542 leaves all her estate to her son, George Hovan. This Will would devise all Anna Hovan's interest in real property and it is averred that she owned Tax map No. 124-R09-542-13 of which the Premises subject of this action is a part.

e). The Premises subject of this action was conveyed to Anna Hoban a/k/a Ann Hovan by deed from Robert Flegal and Mary Flegal, his wife, dated November 23, 1943 and recorded on July 3, 1984 in Clearfield County Deeds and Records Book 956, Page 210. It is averred that Anna Hovan and Anna Hoban were the same person. This deed contains no metes and bounds description but describes the real property as a H & L conveyed to Robert Flegal by Clearfield County Commissioners on August 26, 1943. The deed into Robert Flegal was acknowledged on August 26, 1943.

f). The Premises subject of this action was conveyed to Robert Flegal by deed from the Clearfield County Commissioners in the name of George and Anna Hovan dated August 23, 1943 and acknowledged August 26, 1943 and recorded on July 3, 1984 in Clearfield County Deeds and Records Book 956, Page 208. This deed contains no metes and bounds description, but described the property as a H

& L sold at April 28, 1943 Tax Sale as property assessed to George and Anna Hovan.

g). The Premise subject of this action was conveyed to Clearfield County Commissioners by deed from the Treasurer of Clearfield County in the name of George and Anna Hovan dated July 8, 1940 and acknowledged July 8, 1940 and recorded on July 3, 1984 in Clearfield County Deeds and Records Book 956, Page 205. This deed contains no metes and bounds description but described the property as a H & L sold at January 25, 1940 Treasurers Sale as property assessed to George and Anna Hovan.

h). In Clearfield County Lands Sold to County Book 8, Page 168 it shows that the house and lot in Morris Township assessed in the name of George and Anna Hovan was sold to the County on January 25, 1940 for unpaid taxes. The remarks in said book state that the property was sold at Commissioner's Tax Sale on April 28, 1943 to Robert Flegal.

i). The Premises subject of this action was conveyed to Mrs. Anna Hovan and George Hovan by deed from the Clearfield County Commissioners in the name of Lars Erickson dated December 30, 1936 and acknowledged March 23, 1937 and recorded July 3, 1984 in Clearfield County Deeds and Records Book 956, Page 203. This deed contains

no metes and bounds description but described the property as a H & L sold at November 19, 1936 Treasurers Sale as property assessed to Lars Erickson.

j). The Premises subject of this action was conveyed to the Clearfield County Commissioners by deed from the Treasurer of Clearfield County in the name of Lars Erickson dated February 9, 1932 and acknowledged May 23, 1932 and recorded July 3, 1984 in Clearfield County Deeds and Records Book 956, Page 200. This deed contains no metes and bounds description but described the property as a H & L sold at August 10, 1931 Treasurers Sale as property assessed to Lars Erickson.

k). In Clearfield County Lands Sold to County Book 4, Page 78 it shows that the house and lot in Morris Township assessed in the name of Lars Erickson was sold to the County on August 10, 1931 for unpaid taxes. The remarks in said book state that the property was sold at Commissioner's Tax Sale on November 19, 1936 to George and Anna Hovan.

l). The assessment records of Morris Township, Clearfield County, Pennsylvania shows that George and Anna Hovan are assessed with a house and lot from 1937 to 1940 when sold to the County and that Lars Erickson was assessed with the house and lot from the early 1900's

until 1932 when sold to the County. The assessment to George and Anna Hovan indicates the property is from William Eisenhauer and C. E. Chase but this appears to be in error and is the property of Lars Erickson.

m). The records of Clearfield County show that Anna Hovan a/k/a Anna Hovanec was married to Steve Hovan a/k/a Steve Hovanec and George Hovan was the son of Anna Hovan and Steve Hovan. In Deed Book 956, Page 213 above it indicates that Steve Hovan died on September 18, 1935 but after diligent search of the records in the Clearfield County Register of Wills Office no estate was found on Steve Hovan a/k/a Steve Hovanec.

n). The Premises subject of this action was conveyed to Louis Erickson by deed from O. L. Schoonover dated May 23, 1900 and recorded July 3, 1900 in Clearfield County Deed Book 112, Page 16. This deed contains the same metes and bounds description as the Third Thereof in Deed recorded in Instrument No. 200016288 in subparagraph a). above and is described in paragraph 3. of this Complaint.

o). It is averred that Lars Erickson and Louis Erickson are the same person. After diligent search of the records of the Register of Wills Office of Clearfield County, there is an Estate for Lars Erickson in Clearfield

County Estate File No. 9814 who died June 9, 1924 and he made a joint will with his wife, Christina Erickson, which is filed in Clearfield County Will Book M, Page 479.

p). The joint will of Lars Erickson and Christina Erickson in Will Book M, Page 479 indicates that he was also known as Lars Erickson Flodin and his wife as Christina Erickson Flodin and that they had a daughter, Martha Christina Erickson Flodin. The will leaves the Estate of Lars Erickson a/k/a Lars Erickson Flodin and Christina Erickson Flodin to their daughter, Martha Christina Erickson Flodin.

q). After diligent search of the records of the Register of Wills Office of Clearfield County, no estates were found on Christina Erickson a/k/a Christina Erickson Flodin or Martha Christina Erickson Flodin.

5. The Plaintiff and his predecessors in title to Tax Map No. 124-R09-543-13 have been in open, continuous, notorious, actual, exclusive, visible, distinct and hostile possession of the premises described in Paragraph 3 of this Complaint in excess of twenty-one (21) years immediately preceding the filing of this Action, and thereby claim title by adverse possession.

6. This Quiet Title Action is also necessary to establish a proper chain of title out of which the

Premises subject of this action comes, because of irregularities in the chain of title, including possible unrecorded deeds, variances in the descriptions, tax sale deeds, no tax assessment or unknown tax assessment of the Premises at times, no proof of deaths or estates proving heirs, all of which raise a question as to the chain of title to the property and create a cloud on title.

7. It is finally averred that this Quiet Title Action is necessary to determine the validity or discharge of any document, obligation, assessment or deed affecting any right, title and interest in the property subject of this action, which may affect the rights of the Defendants and their heirs.

8. The Defendants to this Action namely; Louis Erickson a/k/a Lars Erickson a/k/a Lars Erickson Flodin and Christina Erickson a/k/a Christina Erickson Flodin, his wife, Martha Christina Erickson Flodin, Steve Hovan a/k/a Steve Hoban a/k/a Steve Hovanec and Anna Hovan a/k/a Anna Hoban a/k/a Anna Hovanec, his wife, are deceased or their whereabouts are unknown and Plaintiff has made a diligent and reasonable search to locate the whereabouts of the Defendants, but they are deceased or their whereabouts are unknown.

WHEREFORE, Plaintiff brings this action and respectfully requests the Court to decree as follows:

a). That the Plaintiff, his heirs, executors, personal representatives and assigns are seized of an indefeasible title to the property situated in Morris Township, Clearfield County, Pennsylvania, described herein and that an Order and Decree be entered adjudicating that each of the Defendants and any of their heirs, successors, trustees, personal representatives, or assigns be forever barred from asserting any right, title, lien or interest in the within described parcel of land.

b). That such other relief be granted as may be necessary in establishing Plaintiff's title, including determinations on the validity or discharge of any documents, obligations or deeds affecting right, title and interest in the property described herein.


c). Such other and further relief as the Court deems proper.
