MOTION FOR SERVICE BY PUBLICATION
PURSUANT TO PA. R.C.P. NO. 430

AND NOW come the Plaintiffs, LeRoy M. Foster and Gladys A. Foster, his wife, by and through their attorney, David C. Mason, who represents as follows:

1. Movants are the Plaintiffs in an action filed to the above term and number.
2. The Plaintiffs and Defendant were involved in a motor vehicle collision on January 17, 2005, when a 2000 Honda Accord driven by the Defendant collided with the Plaintiff's vehicle on Route 322 in Bradford Township, Clearfield County, Pennsylvania.
3. A Writ of Summons was filed in September of 2006, and service of the same was attempted on Arvinder Singh Bir, the Defendant herein, on or about October 18, 2006, without success.
4. The Defendant is unable to be located, despite Plaintiffs' attempts as detailed on the Affidavit attached hereto as Exhibit "A".

6. All other attempts to locate the Defendant have proved unsuccessful.


