9. Invasion of privacy and trespass each require intentional conduct on behalf of the actor.



The Plaintiff was startled, shocked by the explosion of the impact and the flames and smoke that engulfed her home and herself and had to be transported by ambulance to Phillipsburg Hospital. The Plaintiff sustained and suffered immediate and direct severe emotional distress and physical harm and illness. The Plaintiff has incurred medical bills. She has had ongoing difficulties as a result of this traumatic event due the sensory and contemporaneous observance of the accident and its aftermath.

8. Said collision and all of the herein mentioned injuries and damages sustained by Plaintiff are the direct result of the negligent, careless and reckless manner in which Defendant, Ronald D. Fishel, operated his vehicle as follows:

- (a) Failure to keep proper and adequate control over his vehicle;
- (b) In driving his vehicle in a reckless manner and with careless disregard for the rights and safety of others and in otherwise operating his vehicle upon the highway in a manner endangering persons and property in violation

of 75 Pa.C.S.A. Section 3714 and 3736;

- (c) In being inattentive and failing to maintain a sharp lookout of the road and the surrounding traffic conditions in violation of 75 Pa.C.S.A. Section 3303;
- (d) In driving his vehicle at a speed greater than is reasonable and prudent under conditions in violation of 75 Pa.C.S.A. §3361;
- (e) In operating his vehicle in such a manner as to knowingly and/or recklessly cause damage to Plaintiff, and to Plaintiff's personal and real property in violation of 75 Pa.C.S.A. Section 3717;
- (f) Failure to operate his vehicle entirely within the single lane reserved for vehicles traveling in the same direction as Defendant's vehicle was traveling in violation of 75 Pa.C.S.A. Section 3309.

9. The Defendant caused himself and his vehicle to enter upon the Plaintiff's real and personal property, without privilege or license to do so.

10. The Plaintiff has not been able to go back and reside in her house as she does not have the resources to put her house back together again.

11. The Plaintiff believes it would cost a substantial amount of money to repair her home.

12. The Plaintiff has lost a substantial amount of personal property and household goods, which amount has yet been unidentified and determined, but believes that the combined losses, as a result of this incident, are above the Arbitration limits for Clearfield County, Pennsylvania.

13. The Plaintiff had to also relocate from her residence, has not been able to take her meals at home, as she used to, causing her additional living expenses, which she otherwise would not have had to incur, including the cost of substitute housing.

14. Plaintiff asks for reimbursement of the cost to repair her home, to replace her personal property that was damaged and/or destroyed, and to make her whole with regard to out of pocket expenses, for meals and housing, past, present and future medical expenses, as well as damages for negligent and/or reckless infliction of physical and emotional distress.

15. Plaintiff has reason to believe that the Defendant was consuming or under the influence of alcohol and punitive damages for the reckless driving and/or being under the influence of alcohol.

WHEREFORE, Plaintiff, Jean Skonier, demands judgment of the Defendant, Ronald D. Fishel, in an amount in excess of the amount requiring compulsory arbitration.

1. Upon information and belief, admitted.
2. Admitted.
3. Admitted.
4. Admitted.
5. Denied as stated. It is admitted, however, that on

October 15, 2005, Ronald D. Fishel was operating his vehicle in a southerly direction on Route 729 in Beccaria and his vehicle collided with a utility pole, causing the pole to be sheared at its base and the vehicle subsequently collided with the Plaintiff's resident.

6. Denied as stated. It is admitted, however, that as a result of the collision the residence owned by Plaintiff and located at

2047 Tyrone Pike, Beccaria, Clearfield County, caught fire and sustained damages.

7. After reasonable investigation, Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 7 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

8. Denied pursuant to Pa.R.C.P. Rule 1029(e). By way of further answer, however, Defendant admits liability for the collision.

9. Denied as stated. The collision between Defendant's vehicle and Plaintiff's home was accidental.

10. After reasonable investigation, Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 10 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

11. After reasonable investigation, Defendant is without information regarding Plaintiff's belief as to the cost of repairs to the home. By way of further answer, however, it is averred that Defendant has already paid to Plaintiff an amount of money in excess of the diminution in value of the Plaintiff's real property and the reasonable value of Plaintiff's personality.

12. After reasonable investigation, Defendant is without information as to Plaintiff's perceived value of the personal property lost in the fire. By way of further answer, Plaintiff has failed, upon repeated requests, to provide an inventory and estimate of the items lost. In addition, Defendant believes and therefore avers that Plaintiff has been paid by Defendant an amount in excess of the value of personal property damaged by the fire and the diminution of the Plaintiff's real estate.

13. After reasonable investigation, Defendant is without information concerning Plaintiff's claim for additional living expenses. By way of further answer, however, it is averred that Plaintiff has failed to take reasonable steps to mitigate her damage and loss.

14. After reasonable investigation, Defendant is without information sufficient to form a belief as to the damages and losses suffered by the Plaintiff as a result of the incident. Therefore, strict proof of each and every element of Plaintiff's damages in accordance with the applicable standard is demanded at the time of trial.

15. Denied. It is specifically denied that Defendant was under the influence of alcohol at the time of the incident. Plaintiff's claim for punitive damages should be dismissed.

NEW MATTER

16. Plaintiff's claims are barred or limited by Plaintiff failing to take reasonable, available and appropriate steps to mitigate her own damages.

WHEREFORE, Defendant, Ronald D. Fishel, demands judgment in his favor.

MOTION FOR CONTINUANCE

1. On January 16, 2009, the Court entered a scheduling order, which is attached and incorporated herein as Exhibit A.
2. Sometime after February 5, 2009, Plaintiff's Counsel received Defendant's answers to interrogatories, which were reviewed. On February 20, 2009, in response to improperly answered interrogatories, Plaintiff's Counsel sent a letter to Defendant's Counsel requesting more specific answers to certain questions. A copy of that letter is attached as Exhibit B.
3. By letter dated February 26, 2009 to Plaintiff's Counsel, Defense Counsel answered that Ms. Skonier's auto policy handled her medical bills. A copy of that letter is attached as Exhibit C.
4. In response Defense counsel's prior letter, on March 2, 2009, Plaintiff's Counsel sent a letter to Defense Counsel asking for more specific answers to interrogatories 35 and 36. A copy of that letter is enclosed and attached as Exhibit D, requesting information as to where the Defendant was treated after the accident.
5. On March 9, 2009, Plaintiff's counsel received Defense counsel's letter dated March 5, 2009 with the information that the Defendant was taken to the Altoona Hospital. A copy of that letter is attached as Exhibit E.

6. After receiving information from Defendant's counsel, Plaintiff's counsel then sent a subpoena to the Altoona Regional Medical Center requesting toxicology records for the Defendant as they related to this accident. Sometime after March 17, 2009, Plaintiff's counsel received a refusal from representatives of the Altoona Hospital to supply the information due to the need for a special authorization required under Federal Regulations or a court order signed by a judge for a release of the requested information. A copy of that refusal letter is attached as Exhibit F.

7. On March 27, 2009, Plaintiff's counsel wrote to Defense counsel, requesting authorization be signed by his client, the Defendant. A copy of that letter is attached as Exhibit G.

8. In response to Defense counsel's transmittal of March 31, 2009, on April 3, 2009 Plaintiff's counsel sent two versions of authorizations to be signed by the Defendant. A copy of that transmittal letter is attached as Exhibit H.

9. On April 14, 2009 the Defense counsel provided an authorization signed by his client Ronald Fishel. A copy is attached as Exhibit I. Those records were received last week. A copy of which are being sent to Defense counsel. The toxicology report appears to indicate that some three hours after the accident the Defendant's blood alcohol level was .0154%.

10. Plaintiff's medical records are also important. Plaintiff's counsel sought to secure Plaintiff's medical records from Phillipsburg Hospital, which hospital has closed subsequent to the date of this accident. Plaintiff's counsel personally went to the medical offices operated by the Geisinger Health organization, which are offices adjacent to the hospital and attempted to find a representative who would be able to provide access to the records. Several phone calls were also made to the Geisinger organization with no resolution.

11. A subsequent search revealed that Michael D. Vagnoni, Esq. of Philadelphia was in charge of managing the medical records for Phillipsburg General Hospital and for Jean Skonier.

This information was received after repeated calls to the state Health Department, which did not provide prompt responses.

12. Mr. Vagnoni was contacted by fax on February 27, 2009. On February 27, 2009 a subpoena was issued on Mr. Vagnoni as representative for Phillipsburg General Hospital to provide the medical records for the Plaintiff. A copy is attached as Exhibit J.

13. On March 18, 2009, not having heard a response, a letter was sent to Mr. Vagnoni asking for the Plaintiff's records and to contact us as to their status. A copy is attached as Exhibit K.

14. A phone call was returned by Mr. Vagnoni. Two return calls were placed by Plaintiff's counsel, but no further response was forthcoming. A letter confirming those calls was sent on April 6, 2009. A copy is attached as Exhibit L.

15. On or about April 6, 2009 a telephone discussion was held with Mr. Vagnoni regarding the mechanics of record retrieval and having his office send someone up to Phillipsburg to get the records. Mr. Vagnoni was told that Plaintiff's counsel would meet him in Phillipsburg to pick up the records. A copy of the letter from Mr. Vagnoni is attached as Exhibit M.

16. The lack of being able to be able to secure the information sought has impeded Plaintiff's counsel from being able to adequately represent and prepare a presentation in Plaintiff's case.

17. Plaintiff counsel has generally kept Defense counsel informed of the difficulties with obtaining the requested records. Defense counsel has been advised that a Motion for Continuance will be made. Defense counsel Matthew Taladay has indicated that he has no need to request a continuance but would defer to the court's decision as to grant a continuance.

Wherefore, a request is being made for either a telephone conference or an in person conference to reset dates with regard to completion of discovery, expert witnesses, depositions and the filing of various motions.





Thereafter, he was transferred to the Health South Rehabilitation facility in Altoona. Following his release from Health South, he went to a rehabilitation facility in Clymer, Pennsylvania, the name of which he does not remember. He spent six months at this facility. Following his release, he did out-patient physical therapy at Summit Physical Therapy in Altoona, Pennsylvania, for a period of three months. Mr. Bratic returned to work in November, 2006.







It was a pleasure speaking with you yesterday. As I related, since January 2006 the Philipsburg Area Hospital has been involved in a Chapter 11 bankruptcy proceeding in the Middle District of Pennsylvania. In 2007, the assets of the Hospital, including all of the equipment and the Debtor's leasehold interest in the property, known as 210 Loch Lomond Road, Philipsburg, Pennsylvania, were sold to a company called Rosewood Real Estate, Inc. The sole officer and shareholder of Rosewood Real Estate, Inc. is Dr. Lawrence Adams, who was recently convicted of numerous prescription drug violations and was sentenced to a term of seven (7) years in state prison. Rosewood defaulted on its agreement to purchase the Hospital assets and has further defaulted on its agreement to maintain all of the records of the Philipsburg Area Hospital, including the records you are seeking.

In 2008, during the time when the Debtor was attempting to obtain a restraining order against Rosewood, the Commonwealth of Pennsylvania terminated the Lease and has retaken possession of the Hospital facility. We are now in the process of obtaining the records, however, until that has been accomplished, they will have to be viewed on-site. 




