3. Defendant applied for and received a credit card bearing the account number 5178052181585346 .


4. Defendant made use of said credit card and has a current balance due of \$2121.89 , as of October 04, 2006 .

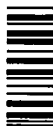


