

**COMPLAINT**

COME NOW, Brink Transportation, Inc., Samuel D. Brink and Brink's Body Shop, by and through their attorney, Dwight L. Koerber, Jr., Esquire and file the within Complaint against Defendant, Espy Transport, LLC. In support thereof, Plaintiffs aver and show as follows:

(1) Plaintiff, Brink Transportation, Inc. is a Pennsylvania Corporation with its offices at 214 Plank Road, Ebensburg, Pennsylvania 15931. Prior to moving during the latter portion of 2006, Brink Transportation, Inc. had its principal offices at 4654 Green Acre Road, Houtzdale, Pennsylvania 16651.

(2) Samuel D. Brink is an individual who is the owner and President of Brink Transportation, Inc. He is the owner of a 1995 Ford tri-axle dump truck, VIN number: 5VA43291. At all times pertinent herein, this vehicle was permanently leased to Brink Transportation, Inc. and was used in Brink Transportation, Inc. in its operations. This vehicle was identified as Brink truck number 302.

(3) In addition to being the owner and President of Brink Transportation, Inc.,

Samuel D. Brink, who resides at 1462 Punkin Ridge Road, LaJose, Pennsylvania, 15753, also operates a proprietorship named Brink's Body Shop. The operations of Brink's Body Shop are located in Clearfield County, but after Brink Transportation, Inc. moved its headquarters from 4654 Green Acre Road, Houtzdale, Pennsylvania 16651 to its current address at 241 Plank Road, Ebensburg, Pennsylvania, 15931, the administrative offices of Brink's Body Shop were moved to 241 Plank Road, Ebensburg, Pennsylvania, 15931.

(4) Defendant is Espy Transport, LLC, which is believed to be a Pennsylvania limited liability company, has its offices and principal place of being 5297 Spruce Creed Road, Tyrone, Pennsylvania 16686.

(5) On or about December 20, 2005, Brink Transportation, Inc. was operating truck number 302, under an arrangement where it delivered coal to the Seward Power Plant in Armaugh, Indiana County, Pennsylvania. When the said truck was waiting in line, immediately in front was a certain coal hauling truck owned by Espy Transport, LLC.

(6) While the Brink truck and Espy Transport vehicle were in line at the Seward Power Plant on December 20, 2005, waiting to make delivery, the truck operated by Espy Transport, LLC backed up and caused the rear end of its vehicle to collide with the front of Brink truck number 302, thereby causing damage to the Brink vehicle.

(7) The actions of Espy Transport, LLC, as described in paragraph 6 of this Complaint, through the driver operating the vehicle on or about December 20, 2005,

were negligent, as the vehicle backed up and hit a stationary vehicle behind it; failed to exercise due concern for the proper care of the vehicles waiting in line behind it; and acted contrary to established protocol for backing up a commercial motor vehicle while waiting in line, when it did not have other person directly guiding it backwards to make certain that it would not hit the vehicle stopped behind it.

(8) Espy Transport, LLC, during the aforesaid incident of December 20, 2005, was negligent as a matter of law and the legal cause of damages to the Brink vehicle number 302. The specific damage that occurred was as follows:

- (a) Damage to hood;
- (b) Damage to grill, and grill shell; and
- (c) Damage to air conditioner condenser and air charge cooler.

(9) Shortly after the Espy truck damaged Brink truck number 302, as discussed in this Complaint, Brink Transportation, Inc. contacted Espy Transport, LLC and explained that there were damages that need to be repaired. Espy Transport responded by telling Brink to do the repairs and present the invoice.

(10) Brink Transportation, Inc. towed truck number 302 to its body shop, and Brink's Body Shop did the repairs that were caused by Espy Transport, LLC vehicle when it backed into the Brink Transportation vehicle on or about December 20, 2005.

(11) Attached hereto as Exhibit A is a true and correct copy of the invoice of Brink's Body Shop which Brink Transportation, Inc. forwarded to Espy Transport, LLC. This invoice represents the work performed on the vehicle, all of which was necessitated and caused by the accident of December 20, 2005 when the Espy Transport vehicle backed into the Brink Transportation vehicle.

(12) Prior to the time that the Espy Transport vehicle backed into and damaged the Brink Transportation vehicle on or about December 20, 2005, the said vehicle was in sound operating condition, was in good physical condition, and was used on a regular basis by Brink Transportation to effect delivery of shipment to the marketplace where the accident occurred.

(13) Brink Transportation and Brink's Body Shop have made numerous and repeated requests to Espy Transport to pay the invoice of March 14, 2006, but Espy Transport has failed and refused to pay the invoice which represents the damages caused by the incident of December 20, 2005 when the Espy Transport vehicle that backed into the Brink vehicle which was fully stationary at that time.


(14) The damages to Brink truck number 302 caused by Espy Transport was \$6,853.83.

(15) In addition to the cost of the physical damages done to the Brink Transportation vehicle, Espy Transport is also indebted to Brink Transportation for down time, with down time representing the days that the said vehicle could not operate because it was in the shop being repaired. Brink Transportation has set reasonable down time, in the amount of two (2) days, as this represents the time that the truck was not capable of being operated and removed from the Brink Transportation business, as a direct result of the negligent actions of Espy Transport, LLC in the December 20, 2005 incident.

(16) The total claim of Brink Transportation, Inc., Samuel D. Brink, and Brink's Body Shop is \$7,853.83. Plaintiffs aver that they individually and jointly are entitled to recover the combined sum of \$7,853.83. In addition to that, Plaintiffs seek prejudgment interest from the date of the repair invoice, March 14, 2006, to the date of the entry of the judgment in this case.

WHEREFORE, Plaintiffs, Brink Transportation, Inc., Samuel D. Brink, and Brink's Body Shop pray that judgment be entered in their favor and against Espy Transport, LLC, in the amount of \$7,853.83 plus prejudgment interest from March 13, 2006 and costs.






