



AND NOW, comes the Plaintiff, DANIEL'S FINE DINING, LLC, Pro Se, and files this Complaint against the Defendant, VEOLIA ES SOLID WASTE OF PA, INC. d/b/a VEOLIA ENVIRONMENTAL SERVICES, on a cause of action upon which the following is a statement:

1. That Plaintiff, DANIEL'S FINE DINING, LLC, [hereinafter referred to as "Plaintiff"] is a limited liability company formed under the laws of the Commonwealth of Pennsylvania, with its principal place of business located at 237 East Market Street, Clearfield, Clearfield County, Pennsylvania 16830.
2. That Defendant, VEOLIA ES SOLID WASTE OF PA, INC. d/b/a VEOLIA ENVIRONMENTAL SERVICES, [hereinafter referred to as "Defendant"] is a corporation formed under the laws of the Commonwealth of Pennsylvania, with its principal place of business located at 6330 Rt. 219, Brockway, Jefferson County, Pennsylvania 15824.
3. That Defendant is in the business of residential and commercial waste removal services.

4. That on or about August 29, 2006, Plaintiff placed twelve (12) cast iron burner grates outside the rear door of the business to be picked up by a service provider that regularly cleans the grates.

5. That while Defendant was making its regular pick up of refuse at the business next door, they picked up the Plaintiff's burner grates and disposed of them.

6. That Plaintiff does not employ Defendant as their waste removal service.

7. That due to the negligence, carelessness and recklessness of the Defendant, the Plaintiff suffered a financial loss.


8. That due to the negligence, carelessness and recklessness of the Defendant, the Plaintiff was forced to replace the burner grates at a cost of \$1,024.40. *See attached Exhibit "A"*

9. That on October 9, 2006, following a hearing at the office of the District Judge, Plaintiff was awarded a Judgment in the amount of \$1,099.90.

10. That on November 2, 2006, Defendant filed an appeal from the award of the District Judge.

WHEREFORE, Plaintiff requests this Court enter a judgement in favor of the Plaintiff and against the Defendant in an amount less than \$20,000.00, exclusive of interest and costs.


