



Eventually I was able to find a full time position causing me to resign from both part time positions due to long hours and scheduling conflicts. I continued to make monthly payments to my credit cards, but also continued to use them for miscellaneous expenses.

I was using my credit cards in order to make ends meet. As I said I continued to make monthly payments, but my credit limit continued to increase along with the interest rates, and monthly payments. I found it increasingly difficult to meet the minimum payment, and would occasionally miss payments or they were late, which added to a bigger rise in interest and monthly payments. It soon became too much and I could no longer make payments. I made life changes to allow for more expendable income each month, but by the time that happened the payments were too big and unmanageable.

In a desperate attempt to try and get out of my mess, I would transfer balances from one credit card to another offering lower interest rates. I transferred some of my Bank of America balance to my new cards. This helped for about one month. I was able to get my Bank of America card to a monthly rate I could handle, but was unable to handle the other bills that had been created. The interest rates and monthly payments rose. Balancing the cards, living expenses and other bills became too much.

### **THIRD AFFIRMATIVE DEFENSE**



**MOTION FOR SUMMARY JUDGMENT**


