1. Plaintiff is CITIBANK (SOUTH DAKOTA) N.A., with place of business located at 701 East 60th Street North, Sioux Falls, South Dakota.
2. Defendant is Cynthia L Marshall, who resides at 1308 Parkview Drive, Clearfield, Clearfield County, Pennsylvania.
3. Plaintiff is a national banking association, engaged in various types of banking business including consumer lending through the issuance of credit cards.
4. Plaintiff furnished consumer credit to the defendant by means of a(n) AT&T Universal credit card with account number 5491130361460280 hereinafter referred to as the credit card account.
5. Plaintiff kept accurate running records of all debits and credits to the account.
6. Plaintiff mailed to defendant monthly statements for the account including the billing statement attached hereto as Exhibit A. The monthly statements accurately stated the previous balance, the debits and credits to the account for the prior billing period.
7. Before plaintiff mailed Exhibit A, defendant had for many months made payments on account of the billing statement or retained the statement without payment.
8. Defendant's actions as set forth above constituted an account stated between parties for the sum of \$8,989.38 which sum reflects the Exhibit A statement balance less credits, if any, which were applied subsequent to the date of Exhibit A.

Wherefore, plaintiff demands judgment against defendant for the sum of \$8,989.38, and the costs of this action.



Cynthia L. Marshall (Defendant), hereby answers the complaint of CITIBANK (SOUTH DAKOTA) N.A. (Plaintiff) for it's self alone as follows and generally denies the allegations of the complaint based on lack of information and belief:

FIRST AFFIRMATIVE DEFENSE

I do acknowledge owing this debt. I am also aware that CITIBANK wishes to collect this debt from me in a timely manner.

SECOND AFIRMATIVE DEFENSE

I obtained this credit card for emergencies after I purchased my first home. At that time I managed it very well. As a single mother, I found myself on my own and responsible for more bills and other unexpected expenses. I was working full time and paying monthly bills and childcare expenses, but still finding it difficult to purchase the things we needed for everyday life. I started charging miscellaneous expenses to my credit card.

I was using my credit cards in order to make ends meet. As I continued to make monthly payments to my credit cards, my credit limit continue to increase along with the interest rates, and monthly payments. I found it increasingly difficult to meet the minimum payments, which were only covering the interest payments.

In a desperate attempt to try and get out of my mess, I would transfer balances from one credit card to another offering lower interest rates. I transferred some of my CITIBANK balance to my new cards. This helped for about one month. I was able to get my CITIBANK card to a monthly rate I could handle, but was unable to handle the other bills that had been created. The interest rates and monthly payments rose. Balancing the cards, living expenses, and other bills became too much.

I continue to work a full time job and to raise my daughter making it difficult to find a part time job to help cover the expenses. Financially I am struggling. I feel the stress of being in debt every day, along with personal stress and with work and being a single mother. I am trying my best to resolve this debt as well as cope with my other life stressors.

THIRD AFFIRMATIVE DEFENSE

As I said before, I do acknowledge this credit card debt. I have recently sought the help of Consumer Debt Relief Group, in the attempt to repay this debt. I have been working with them for about ten months. Every month I place money into a savings account with the intentions of resolving this debt. I ask for more time to allow for more deposits into this account. I am confident that in time I will have the means to resolve my credit card debt.

WHEREFORE, Defendant requests that:

1. Plaintiff takes nothing by way of his complaint: and
2. For Defendant's cost of suit.
