


AND NOW comes the Defendant, BETTIE J. STERNESKY, and files this Answer to Complaint, alleging as follows:

6. It is admitted that Plaintiff demanded one-half of the said account (being the sum of \$6,341.33) and that Defendant refused to pay this sum to Plaintiff. It is denied that Plaintiff is entitled to a one-half ( $\frac{1}{2}$ ) share of the account. There being three joint owners, two-thirds ( $\frac{2}{3}$ ) of the account were held by Defendant and her husband, Marcellie T. Sternesky, as tenants by the entireties, and one-third was held by Plaintiff and his father. Upon the death of Defendant's husband, she inherited two-thirds of the account (being the sum of \$8,455.03),

which was exempt from Pennsylvania inheritance tax. Plaintiff inherited one-third of the account (being \$4,227.64) and owes Pennsylvania inheritance tax on the one-half of this sum (\$2,113.82) that was attributed to his father. This interpretation has been made by the Pennsylvania Department of Revenue in its Information Notice dated October 25, 2006, a copy of which is attached hereto, made a part hereof, and labeled Exhibit A. Plaintiff is owed only the sum of \$4,227.64 less the Pennsylvania inheritance tax (at the rate of .045) owed on the decedent's one-half share of the one-third interest he held with his son, the Plaintiff herein. Plaintiff is therefore entitled only to \$4,227.64 less Pennsylvania inheritance tax of \$95.12, or the sum of \$4,132.52.

7. Admitted.

WHEREFORE, Defendant requests that the Court find that Plaintiff is owed only the sum of \$4,132.52 by Defendant (as previously determined by the Pennsylvania Department of Revenue), and assess all costs of this unnecessary action to Plaintiff.




