COMES NOW, James A. Collins d/b/a Collins Masonry, by its attorney Peter F. Smith, who states in support of this complaint:

1. The Plaintiff is **JAMES A. COLLINS d/b/a COLLINS MASONRY**, with business mailing address of P. O. Box 431, Hyde, Clearfield County, Pennsylvania 16843.
2. The name of the Defendant is **BRETT BLOXDORF d/b/a BLOXDORF CONTRACTING**, with address of 318 Wilderness Lane, Mahaffey, Clearfield County, Pennsylvania 15757.
3. On or about August 18, 2005, the Defendant contracted with the Plaintiff to perform masonry work at a home which the Defendant was constructing for Jerry Duffell at Punxsutawney, PA.
4. The parties' agreement was verbal.
5. Defendant agreed to pay Plaintiff on a cost-plus basis of \$30.00 per hours for stone mason's labor and \$20.00 per hour for stone mason's laborers, plus the cost of materials, plus 10% mark-up. Any balance unpaid after thirty days would accrue interest at the rate of 12% per annum.
6. Plaintiff commenced the masonry work and continued until Defendant shut the job

down on December 8, 2005 prior to completion. Defendant advised Plaintiff that work would resume and be completed in the spring of 2006.

7. To date, Defendant has not recalled Plaintiff to the job and unilaterally breached his contract with Plaintiff by advising Plaintiff that he terminated the project with the homeowner.

8. The total due to Plaintiff from Defendant for services pursuant to their agreement is \$11,097.50 plus interest.

9. Plaintiff sent the Defendant invoices for amounts due on or before thirty (30) days after January 23, 2006.


10. To date, Defendant has paid the Plaintiff \$44,785.00 toward the amount due.






